Public Comment: No one present

Reports of Standings/Special Committees:

Mr. Towers: The Internal Management Committee met this morning to discuss Health Insurance benefits for 2017. The Chairman reported that they discussed the proposed POS changes that will bring it more in line with our HMO plan. Personnel Officer Byrne will put in a resolution for next week for these changes.

Mr. Frey: The Finance Committee has met several times and will continue to meet. Everyone should have the Tentative Budget on their desks. Budget Officer Mezzano will be taking us through this.

The Chairman wants everyone to expect some long days discussing the budget.

Public Health and the Department of Social Services will be in this afternoon to discuss some issues. Public Health is more about a position and Department of Social Services is to review how we can decrease a line item due to the placement of a child.

Mr. R. Wilt: For the PSAP they are working out the final details but have pushed off the start date until next year. They will not be holding their usual conference calls for a month. Mr. Farber has one detail to work out plus a couple from Frontier, but the rest of the County's work is done.

The microwave tower changes have been made and they should have that all worked out by next Monday, which will be an important call to make sure everything is confirmed.

He and Don have been pushing to pay for the dispatch console out of the PSAP grant that expires at the end of this year.

The Chairman stated it's the way the timing works out under the one PSAP grant, we need to switch it out and charge it off to the grant that will be expiring at the end of the year.

The Chairman stated there was an announcement for another \$45,000,000 in communications; Don's take on that is it's going to be formula based, not competitive which could be good news for us.

Mr. D. Wilt: There's a Health Committee meeting today at 1:00 PM to discuss hiring RNs, not sure if the problem is because of salary or lack of RNs.

The Chairman: Attended the Review Board meeting last week and the discussion was on the upcoming classification package. The Chairman passed around the classification material that he received.

The Chairman pointed out a parcel in the Town of Benson that a hunting club owns that is on top of Cathead Mountain as well as on the bottom. They are separated by Forest Preserve; Teresa and Betty tried to work out a constitutional amendment to do a land swap to get them access. Just so everyone knows it is a site, according to Mark Hoppe's evaluation, that is our best way of getting coverage on the southern part of Route 30 corridor across the Benson road. The commute for Wells, Benson and Hope Ambulances are highly impacted by our ability to get on Cathead Mountain and continued to discuss the importance of how it is classified.

The Chairman reported we had passed a resolution, as did Essex, entering into the Access MOU. He presented that resolution at Inter-County and it was passed unanimously. A number of counties have agreed to pass it locally. They also had a tour of downtown Historic Plattsburgh.

PROPOSED LOCAL LAW NO. 9 OF 2016 State of New York County of Hamilton

A LOCAL LAW OVERRIDING THE TAX LEVY LIMIT FOR HAMILTON COUNTY FOR 2017 AND AUTHORIZING THE ADOPTION BY HAMILTON COUNTY OF A BUDGET

FOR 2017 THAT WILL REQUIRE A TAX LEVY THAT IS GREATER THAN THE TAX LEVY LIMIT FOR THE 2017 FISCAL YEAR

BE IT ENACTED, by the Board of Supervisors of the County of Hamilton as follows:

- <u>Section 1.</u> **Title:** This Local Law shall be known as "Hamilton County Responsible Budgeting Law of 2016".
- Declaration of intent: The intention of this local law is to comply with the requirements of General Municipal Law Section 3-c (5) prior to adopting the 2017 Hamilton County Budget. The slow recovery of the national, state and local economies from the most recent recession and the continued financial obligations imposed on the County by the State in the form of mandated government activities not fully funded by the State are conditions beyond the control of County government. Notwithstanding these circumstances the County will need to provide services in 2017, in addition to those mandated by the State, which are important to our citizens. After serious and sustained efforts to minimize the amount of the tax levy, and to project the tax levy limit for Hamilton County for 2017, it is clear that a responsible budget for 2017 will require a tax levy that will be greater than the tax levy limit calculated pursuant to applicable State Law.
- <u>Section 3.</u> **Budget Authorization:** The Board of Supervisors hereby overrides the tax levy limit for Hamilton County for 2017 and authorizes Hamilton County, after completing all required procedures for the adoption of a budget, to adopt a budget for 2017 that will require a tax levy increase that is greater than the tax levy limit calculated for 2017 pursuant to Section 3-c of the General Municipal Law.
- Section 4. Severability: If any section, subsection, sentence, clause, phrase or other portion of this local law is for any reason declared unconstitutional, or invalid or in whole or in part by any court of competent jurisdiction, such portion shall be deemed severable and such unconstitutionality or invalidation shall not affect the validity of the remaining portions of this law which remaining portions shall remain in full force and effect.
- Section 5. **Effective Date:** This local law shall take effect upon the date on which a certified copy of this local law is filed in the office of the Secretary of State pursuant to section 27 of the Municipal Home Rule Law.

WHEREAS, Citizen Advocates Inc. of Franklin County, DBA North Star Chemical Dependency Services, has agreed to maintain licensed substance abuse clinics at the Indian Lake and Lake Pleasant offices of HCCS, and

WHEREAS, Citizens Advocates, Inc. will provide administrative and management support to HCCS clinical staff co-located at these locations such that HCCS clinical staff can provide both mental health and licensed substance abuse services to Hamilton County residents, and

WHEREAS, this administrative and management support will include operational management of the substance abuse clinics, supervision of county clinical staff for the provision of substance abuse services, quarterly utilization of services reports to the Local Government Unit and other supports as necessary to comply with applicable state and federal regulations, be it

The Chairman stated there will be some long meetings coming up for the budget. He is hoping to adopt the budget November 16th; if not, they will have to add a session Thanksgiving week.

Budget Officer Mezzano started his review of the Tentative Budget. There are still some considerations that the Board needs to address such as new positions and salaries.

The Chairman stated, on the first page there aren't any adjustments to the fund balance that we can anticipate. As we refine our estimates for appropriations and revenues, we tighten the appropriation numbers and try to bring every bit that we can out of the revenue numbers; then we reach a tipping point where you can no longer have the expectation that you have as much fund balance. We will have to take a scrutinizing look at the fund balance numbers, the other number that maybe worth just touching on briefly is sales tax. So far this year we have not seen the sales tax revenue that we saw last year.

The Chairman stated they are having a meeting this afternoon with Department of Social Services Commissioner Bly and Principal Account Clerk Eldridge to see if we can close a large gap that they have.

Budget Officer Mezzano stated that Clerk Abrams knows so much about the history of the budget that she picks up on things that are off. She is very good about making the numbers that they have as close as they can get it. He thanked Clerk Abrams enormously.

Mr. Frey stated they can't place a value on Clerk Abrams for the work she does with the budget.

Mr. D. Wilt stated, as far as assessors, he has spoken with Mr. Wells and he feels they can't afford to go the county route; they are just going to try to work something out between the two towns in regards to an assessor position. Once more towns join then it will become more affordable for them.

Mr. D. Wilt asked in regards to the Public Health RN position they are advertising, what line item number is that, Office Mezzano stated 4010.106, that is set at the hire rate but depending upon experience that could possibly change such as one of the Sheriff's lines did for a lateral transfer on a Deputy.

The Chairman stated as everyone goes through the budget slower, if you have any questions please email Budget Officer Mezzano and himself so that they can get you answers.

Mr. D. Wilt received a phone call from Cooperative Extension, Nancy Welch asked him to consider her increase. The Chairman stated there is something that she may be able to help us with because we don't have the expertise for someone to do environmental evaluations or impacts. And there is a lot of conversation going on throughout the Adirondacks about the environmental impact associated with mountain biking and gravel roads, etc. They have spoken with her in regards to Cornell having resources and we know a couple of towns that need people to help evaluate those types of impacts.

The Chairman stated he will set up the Finance Committee meetings for Monday and Wednesday afternoons next week to discuss salaries with the departments that have requested more.

Mr. Towers stated on a personal note he wanted to thank Mr. & Mrs. Edwards for yesterday. Mr. Frey added a thank you to Superintendent Eldridge and his crew for all the great work that they have been doing.

The Chairman attended the Hamilton County EMS Council last night in Inlet and it was well attended. Now that everyone is attending more meetings they are starting to clearly identify issues that need to be worked on.
