AUTHORIZING COUNTY DPW TO HIRE MEO IN LONG LAKE

WHEREAS, the County DPW has an open MEO position at the Long Lake garage, and

WHEREAS, the County Highway Superintendent has interviewed Kenneth Walters of Indian Lake, and

WHEREAS, the Highway Superintendent recommends that Kenneth Walters be hired full time effective November 14, 2016 at MEO Step Hire, be it

Budget Review:

Budget Officer Mezzano asked about the software for Public Health. Mr. D. Wilt was going to get more information. He stated that they are looking at other options that would be more reasonably priced. The Chairman asked if they have a lower option which we can afford; he feels they should take the higher end software out of the budget and put in the alternative. Mr. D. Wilt reported they are looking at a startup cost of \$8,000 and then a monthly fee of \$800 for a total of \$9,600; a grand total of \$17,600.

After some discussion it was decided to decrease line item A4010.404- Contracts – for a total of \$118,800.

Budget Officer Mezzano asked everyone to go to revenue code A3619 and change the amount to \$89,260. Mr. Farber stated this increase is due to a child that is being placed outside the county.

Officer Mezzano then asked them to go to expenditure A6070.403 – Services for Recipients/TANF - decrease this from \$140,016 to \$135,390.

With these changes Officer Mezzano stated they are looking at an increase of 3.45%. Mr. Farber wanted everyone to keep in mind that they haven't thoroughly gone through the highway budget.

Mr. Farber and Mr. Frey threw out ideas on how to setup accounts for an Assessor that two towns will be sharing in expenses as well as work and how the county will bill them.

Mr. Farber stated that everyone has had a couple of days to review the budget and asked if anyone had any questions. The issue remains that the budget is up well above, not only the Tax Cap, but also above 2%; there isn't any really clear path to getting that down. We can shave here and there but then as Mr. Frey has made the point so often, when we do that then we start over estimating

revenues or under estimating expenditures. Then you end up in a cycle where next year you have to increase or reduce those things and at the same time you have less fund balance which could come back to bite you in a significant way. He continued to discuss.

Mr. Farber stated we need to find our comfort level with the budget being up and reminded everyone that they still have a couple of days of discussing salaries with department heads that will be asking for more money.

The Board members discussed the fund balance. Mr. Farber feels they have been able to stabilize the fund balance over the past two years. The discussion then turned to what is driving our costs and all of the mandates.

Mr. Farber feels that they need to share the department head comparison that Budget Officer Mezzano put together with the department heads that are coming in to discuss their salary.

Mr. Farber reviewed the departments that they will be meeting this afternoon.
