### MAY 4, 2017

The Board convened at 10:30 A.M. in the Supervisors' Chambers at the Court House, Lake Pleasant, New York, with the Chairman, William G. Farber presiding. Mr. Farber led the members of the Board of Supervisors in the Pledge of Allegiance to the Flag, and an opening prayer.

A motion was made to accept the minutes of March 27, 2017 and April 7, 2017 by Mr. Snyder, seconded by Mr. D Wilt. Carried.

Public Comment: No one present.

Reports of Standing/Special Committees:

Mr. Towers: Mr. Edwards and he attended Inter-county in Fulton County. Assemblyman Butler was the keynote speaker; the focus was on State legislature, Budget Process and adopting the state budget. Most of the conversation being about shared services and county wide plans.

Mr. Frey: Requested support for Resolution No. 1 on the agenda in regards to shared services across county lines.

Mr. R Wilt: PSAP is moving along. The PSAP turn on date has been pushed back. No date as of right now but probably September. The Chairman added that the only thing he had seen contrary on that was the challenge of training during the summer months to prepare for September.

Mr. Edwards: Went to the MEGA meeting and brought back information for the Board to look at. MEGA is expanding their programs and he encourages towns to look in to joining.

The Chairman introduced Alan Hipps who is the Executive Director of the Housing Assistance Program of Essex County (HAPEC). He will be providing an update on the Housing Rehab Program.

Mr. Alan Hipps handed out information and then proceeded to review it. He discussed getting a viable contractors list and how the contractors need to have all the proper paperwork including workmen's compensation. The program funding is going to take care of a good majority of the people on the waiting list. The problem with that is that if the County wants to go for another round of funding then we will need to have more names. HAPEC has also picked up another activity with Essex County that is septic only. Mr. Towers asked Mr. Hipps if it would still be the same income eligible guidelines. Mr. Hipps stated that it is for home owners, and yes the income thresholds would stay the same.

Mr. Hipps stated that we need to do a second public hearing during the current grant administration. We will hold that in the next couple of months. The Chairman asked about the application cycle and when we would have to apply and how that would work into the County currently not having a list. Mr. Towers said that getting the word out now to gain another grant is something he agrees with but making sure we tell the applicants that it is just that. Mr. Hipps said that his office could send a "Dear Resident" letter out to the Enhanced STAR recipients saying that there is a program to help with housing rehab. The Chairman said that it should include that the County is in the prospect of applying for some grant funding.

The Chairman introduced Highway Superintendent Eldridge.

Superintendent Eldridge wanted to let the Board know that he had the kick off meeting with Barton & Loguidice for Solid Waste. They are going to be starting the CFA process. They will be drafting sample resolutions that the Board, along with the towns, will have to pass. They will also be looking for some letters of support. The application deadline is July 28<sup>th</sup>; hoping to get it in the first part of July. He is having meetings in the next week with DOT and Greenmail Pederson for the Hatchbrook Bridge project. Then he will be able to give an update on that.

WHEREAS, financial pressures on local governments budgets are forcing municipalities to examine how they deliver their services, and

WHEREAS, the governor of New York State has encouraged all local governments to find efficiencies and reduce the number of agencies wherever possible, and

WHEREAS, the Towns of Webb and Inlet in Herkimer and Hamilton Counties are currently engaged in formal discussions regarding the possibilities of consolidating police protection services, and

WHEREAS, current New York State law does not contain a provision allowing Towns to consolidate police departments across county lines, and

WHEREAS, the communities believe it is now appropriate to explore this opportunity for enhanced efficiencies in municipal service delivery, and

WHEREAS, the elected officials and staff of both Towns have had a longstanding practice of working together to resolve mutual problems, and

WHEREAS, the Towns of Webb and Inlet Police departments have had an inter-agency agreement in place allowing for shared policing, they still have duplicated staffing as in separate Police Chiefs and equipment needs that could be streamlined, and

WHEREAS, the Town Supervisors, Police Chiefs, and designated Town Board members serving on a jointly formed committee have been holding monthly meetings open to the public, and

WHEREAS, the Towns have gone as far as they can without New York State legislative approval passed in both the Assembly and Senate then signed into law by the Governor, and

WHEREAS, both Towns believe that the aforementioned issue can be resolved with support from our New York State legislative bodies and the Governor's Office, now, therefore, be it

RESOLVED, that the Towns of Webb and Inlet in Herkimer and Hamilton Counties request the same consolidation privileges across shared county lines that those within county lines enjoy under New York State Law.
