Reports of Standing/Special Committees:
Mr. Towers: Stated that the Adirondack Association of Towns and Villages (AATV) meeting was well attended. The program was centered on both zombie properties and broadband. The Chairman also stated that there was a nice proclamation for the outgoing President of the Association as well as congratulations to Mr. Brian Wells for becoming the second Vice President.

Mr. Frey: Stated that there was a very productive shared services meeting in Albany with Senator Tedisco and Assemblyman Butler. Those attended were Inlet Police Chief, Robert Moore and Bill Farber. Thank you to Bill Farber for helping put the meeting together.

Mr. D. Wilt: Stated that he will be attending the Professional Advisory Committee (PAC) meeting scheduled for December $21^{\text {st }}$.

The Chairman introduced Eliza Darling, County Historian.
Ms. Darling handed out her Annual Report to the Board and took some time going over it. She stated that she carried out 40 events under the grant in 2016, all between the months of June and December. One of the hidden benefits that came out of 2016 was increased visibility for the Hamilton County Historian's Office. She stated that she was able to meet so many people and
come away with a contact list that would have taken her close to 10 years otherwise so it was well worth it. Going into 2017 she finished up some loose ends of 2016 and took on some new projects. One of the things she did was work on the application for a Records Management Archiving grant. You need to actually know something about archiving before you can get the grant so she has been trying to learn as much as she can. She stated that she has heard that this year is a good year to apply. She is applying for $\$ 75,000.00$; some of the money will be used towards hiring a professional archivist, which is insisted upon as part of the grant. The grant, if awarded, would flow from June 2018 through June 2019. She has teamed up with North Country Public Radio (NCPR) to do a project called North Country at Work. They will be documenting our labor history and uploading it to a part of the NCPR website as a digital archive. She is working with the Town of Hope to plan their Bicentennial.

Ms. Darling is working on an idea for 2018; expanding the People's History Project. In speaking with the community she has found the tours are very popular so she is considering making it into a series of People's History Tours. She would like to divide it up into three different types. Onebeing walking tours for historic hamlets. Two-Hiking Tours because a lot of our history has been swallowed up by forest preserve but we can still get to some of those places. Three-Lakefront Tours even though not really sure on how to go about doing them. With regard to funding and partners she has talked with NCPR, who has said they would like to partner, ROOST and the possibility of New York State Parks and Historic Preservation (NYSOPRHP). Funding wise The National Endowment for Humanities (NEH) offers money for exactly this kind of thing. What's nice about the Historic Places grant is that it comes in two forms, an initial planning grant and a subsequent implementation grant, so it wouldn't necessarily be all in one year. As she is only in the preliminary stages she will be coming back to the Board for authorization when there is something more solid. There is talk that the Trump Administration is going to abolish the NEH so she is hoping the County can get the money before, or even if, that occurs.

Mr. Frey stated that it would be wonderful if the history tour could be done on a mobile path. Ms. Darling stating that she agrees and that would be where some of the funding would come in handy.

Mr. Towers stated that they are all very excited and that she is doing an excellent job.
Mr. Wells stated that she should have mentioned the Adirondack Challenge because of the fact that she was reaching out to people all over the state that were there for that event. He has heard nothing but positive feedback.

The Chairman thanked her for coming in and congratulated her on a great job.

Mr. Frey: Stated that it is Snodeo this weekend in the Town of Webb starting this Saturday.
Mr. Edwards: Stated that Ms. Eliza Darling will now be the Town of Hope's Historian.
The Chairman stated that our legislators have been working hard on a two prong strategy with respect to the police consolidation.

The Chairman further stated that based on this morning's Finance meeting, a reminder that there will be a resolution in 2018 amending Board of Elections budget for temporary help. There will also be a resolution at the next meeting amending the contract with the Welfare Fraud Investigator taking effect January 1, making his insurance a reimbursable expense.

The Chairman stated that there will be three Committee meetings this afternoon; Health is at 1PM, Public Works is at $1: 30 \mathrm{PM}$ and Finance is at $2: 15 \mathrm{PM}$.

The Chairman stated that part of what was mentioned at the Adirondack Association of Towns and Villages (AATV) meeting in Lake George was that Partners, Review Board, AATV and Adirondack Park Agency (APA) are currently working on the agenda for Local Government Day for April. If Supervisors have things that they would like to see on the agenda or highlighted then please make sure you let him or Mr. Wells know.

The Chairman stated that Adirondack Day will be April $16^{\text {th }}$ in The Well of the Legislative Office Building (LOB). There could be an event at lunch time honoring both Senators Englebright and Little for shepherding the amendment through the two Houses of legislation for two years in a row. It's a comprehensive amendment that fixed a lot of road/utility based projects but didn't fix them all. They failed to pass Camp Gabriel's two years in a row. There is a need to work with both Senator Englebright and Assemblyman Stec along with a need to educate people of New York State more about the Adirondack Park. Maybe we should find the time, energy and resources to
do the New York City Adirondack Day. In a conversation the Chairman had there was an idea about having the New York City presentation titled "Your Adirondack and Catskill Parks." Having someone from the Catskills along with a couple of us describe it.

The Chairman stated that the first piece of the Cycling Grant has been authorized. Think about within your communities if there are bicycle vendors and cycling opportunities that we want to incorporate into this planning effort. What we applied for is strategic planning money to develop an Adirondack Cycle Strategy starting with the Great South Woods.

The Chairman stated that there was a tourism round table earlier in the week in Lake Placid that greatly focused on tourism amenities.

The Governor is announcing the Regional Economic Development Council (REDC) awards on December $13^{\text {th }}$. We should find out about our County Shared Services grant that day as well.
