A LOCAL LAW FIXING THE ANNUAL SALARY OF THE
HAMILTON COUNTY DISTRICT ATTORNEY

Legislative Intent: The Hamilton County District Attorney's annual salary for the year 2017 was set by the Hamilton County Board of Supervisors at One Hundred Thousand Dollars (\$100,000.00).
