Before the Budget Review the Chairman remarked on the 2020 Local Update of Census Addresses program. NYSAC and DOS are encouraging all counties to participate. If towns are not going to participate at the local level please make sure you percolate that information up to the group here. Probably makes sense to set up a small team that will work on this issue with Christy Wilt and Barry Baker along with a couple of interested Supervisors.

### **BUDGET REVIEW:**

Chairman stated that Mr. D. Wilt, Mr. Towers and himself met with Office for the Aging (OFA) and talked about our appropriation. For the new Supervisors, OFA appropriation is really linked back to the Senior Meal Sites, and where meals on wheels get delivered and provided throughout our County. There was a good conversation around the 2 prong strategy. Both Community Services and Public Health have money available that they received through Delivery System Reform Incentive Program (DSRIP) for community engagement. The thought was that both Departments have a fairly rich network of programs set up around the schools, youth, WIC, etc. They would both conceive that there is a need to do some more community engagement with our senior population. We can propose the idea to Deanna Park, OFA Director, that those two departments might contract with OFA to utilize the senior meal sites as points of entry into the senior population. They would set up programs when there are events at the Senior Meal Sites, which Ms. Park indicated that the numbers increase. So the idea is if Community Services and Public Health use some of their DSRIP monies to contract with OFA then Ms. Park stated that would offset some of the County cost. Bringing the OFA line item from \$280,000.00 down to \$250,000.00. The second part of the conversation was efficiency and if there were some things we could do around the meal sites. Such as, how the meal prep takes place, how the food gets moved from one meal site to another and staffing changes. The Chairman stated that he thinks that OFA has experienced what they thought were some issues in being able to get to mold the program in a more efficient way and he feels that the Supervisors could be more helpful with this. Mr. Towers added that we can't tie OFA's hands in the way that they manage the program. Progress is being made but there is going to be tough decisions to be made in the future. The message should be that we are supportive of the program; that people are not going to lose their program, not miss a meal. We just need to run this as a business.

The Chairman stated that there has been a lot of conversation around Cornell Cooperative Extension this year as Nancy Welch, Executive Director, is retiring. He was asked to pursue a couple of different things. Being a fairly significant contributor to Cornell there was some unease among the Supervisors to not being involved in the hiring process and wanting to see how the models worked in other counties where there is partnership with another county. He has had a couple conversations with Cornell Cooperative Extension in Warrensburg per Mr. Wells' suggestion. During those conversations he found that their Cooperative Extension was on a positive trajectory. They have been adding money to their appropriation on an annual basis trying to get the funding of it up. He was told that they have 5 applicants for the Executive Director position. At the local board level there has been some discussion on how Cornell can raise the visibility of what Cornell Cooperative Extension not only does, but what it has available in the way of resources. The Board has recognized that they are an under-utilized resource in terms of some of the expertise. He feels we should keep the funding in the budget.

Motion was made to open the Public Hearing on the 2018 Tentative Budget by Mr. Towers, seconded by Mr. D Wilt. Carried. No public present.

Motion to open the Public Hearing on Proposed Local Law No. 12 of 2017 – A Local Law Overriding the Tax Levy Limit for Hamilton County for 2018 and Authorizing the Adoption by Hamilton County of a Budget for 2018 that may require a Tax Levy that is Greater than the Tax Levy Limit for the 2018 Fiscal Year by Mr. Frey, seconded by Mr. Edwards. Carried. No public present.

Chairman took some time explaining the revenue streams for the new Supervisors. He stated that when you take out the revenues that come back program by program we have basically two revenue streams at the County, Real Property Taxes and Sales Tax. We had to reduce the amount of Sales Tax that we anticipate as revenue for 2018 by \$200,000.00. That is about 2.5% on the tax rate right out of the gate. Changing health insurance for the employees along with programmatic changes in some of the departments helped offset.

The Chairman stated that he has spoken with Tracy Eldridge, Highway Superintendent, along with Mr. Wells about increasing within the Highway appropriations the equipment line by \$40,000.00, DM5130.201, for the anticipated purchases and reducing Bridges, D5112.203, by \$40,000.00.

The Chairman stated that after meeting with Mr. Wells, Mr. D. Wilt and Barry Baker, Real Property Director, regarding the Assessor Salary they agreed to leave the amount in the proposed budget.

Mr. R. Wilt asked when the Hamilton County Solid Waste Contract was ending. The Chairman stated that it is set to end December 2018. He explained how 20 years ago this came about. He has spoken with Essex County, only other county in NYS completely within the Adirondacks, and they are looking to approach NYS to see what can be renegotiated to reflect inflation. The Chairman has also spoken with Betty Little and Dan Stec and there is talk of making a 2 county

pitch. He shares Essex County's sense that we should go after an extension. Mr. Towers asked in the development of the Solid Waste Plan that Barton & Loguidice is currently working on are there numbers yet to look at. The Chairman explained what Barton & Loguidice was brought on to do and why.

A motion to close the Public Hearing for the 2018 Tentative Budget as well as the Public Hearing for the Proposed Local Law No. 12 of 2017 by Mr. Frey, seconded by Mr. Towers. Carried.

The Chairman called for a motion to adopt Local Law No. 12 of 2017 – A Local Law Overriding the Tax Levy Limit for Hamilton County for 2018 and Authorizing the Adoption by Hamilton County of a Budget for 2018 that may require a Tax Levy that is Greater than the Tax Levy Limit for the 2018 Fiscal Year.

After Local Law No. 12 of 2017 moved and seconded, Mr. Frey stated that he would like to point out that the numbers Budget Officer Mezzano had mentioned regarding expenditures are low. This is definitely a reflection of the loss of Sales Tax. The Chairman stated that it does speak to a need for the Board to focus more attention and energy to the business loss.

Mr. Frey stated that he wants to look to Albany as a suggestion for a ship to address for online purchases opposed to post office boxes.

After the discussion the Chairman called for a vote. Motion carried.

## LOCAL LAW NO. 12 OF 2017 State of New York County of Hamilton

## A LOCAL LAW OVERRIDING THE TAX LEVY LIMIT FOR HAMILTON COUNTY FOR 2018 AND AUTHORIZING THE ADOPTION BY HAMILTON COUNTY OF A BUDGET FOR 2018 THAT WILL REQUIRE A TAX LEVY THAT IS GREATER THAN THE TAX LEVY LIMIT FOR THE 2018 FISCAL YEAR

BE IT ENACTED, by the Board of Supervisors of the County of Hamilton as follows:

- Section 1. Title: This Local Law shall be known as "Hamilton County Responsible Budgeting Law of 2017".
- <u>Section 2.</u> Declaration of intent: The intention of this local law is to comply with the requirements of General Municipal Law Section 3-c (5) prior to adopting the 2018 Hamilton County Budget. The slow recovery of the national, state and local economies from the most recent recession and the continued financial obligations imposed on the County by the State in the form of mandated government activities not fully funded by the State are conditions beyond the control of County government. Notwithstanding these circumstances the County will need to provide

services in 2018, in addition to those mandated by the State, which are important to our citizens. After serious and sustained efforts to minimize the amount of the tax levy, and to project the tax levy limit for Hamilton County for 2018, it is clear that a responsible budget for 2018 will require a tax levy that will be greater than the tax levy limit calculated pursuant to applicable State Law.

- <u>Section 3.</u> Budget Authorization: The Board of Supervisors hereby overrides the tax levy limit for Hamilton County for 2018 and authorizes Hamilton County, after completing all required procedures for the adoption of a budget, to adopt a budget for 2018 that will require a tax levy increase that is greater than the tax levy limit calculated for 2018 pursuant to Section 3-c of the General Municipal Law.
- <u>Section 4.</u> Severability: If any section, subsection, sentence, clause, phrase or other portion of this local law is for any reason declared unconstitutional, or invalid or in whole or in part by any court of competent jurisdiction, such portion shall be deemed severable and such unconstitutionality or invalidation shall not affect the validity of the remaining portions of this law which remaining portions shall remain in full force and effect.
- <u>Section 5.</u> Effective Date: This local law shall take effect upon the date on which a certified copy of this local law is filed in the office of the Secretary of State pursuant to section 27 of the Municipal Home Rule Law.
