#### BY MR. WELLS:

WHEREAS, Four plus miles of the Sanford Line, currently operated by Saratoga and North Creek Railway (SNCR), LLC is in Hamilton County, and

WHEREAS, Hamilton County joined with many of our Local Government colleagues and the NYS Governor, in having grave concerns over Oil Tanker Storage on said Line, and

WHEREAS, Rental of space on the Rail Siding and particularly the main Line for Oil Tanker Storage, was inconsistent with both the Adirondacks and use of the Rail Line for movement of Freight from the Tahawus Mine site, and

WHEREAS, the unified voices of opposition were successful in getting the Oil Tankers removed from the Sanford Lake Branch Line thanks to NYSDEC and others, and

WHEREAS, there are now no tankers stored on the Main Line or any of the Rail Sidings, but there is however the prospect of SNCR, LLC selling said Line to OmniTrax, and

WHEREAS, OmniTrax is a highly regarded Short Line Operator, and

WHEREAS, this opportunity coupled with Paul Mitchell's desire to ship product over the Line, eliminated the necessity for NYSDEC to proceed with their Adverse Abandonment Action, and

WHEREAS, the Adverse Abandonment Action is actually inconsistent with the Rail Operations plan for the Sanford Lake Branch Line, as well as the fact that the NYSDEC Filing is actually inconsistent with the facts, and

WHEREAS, Warren County which owns the adjacent section of Rail Line opposed this action by NYSDEC, as does the Town of Newcomb, home to the Mitchell Stone Products' Mine at Tahawus, now, therefore, be it

RESOLVED, that the Chairman of the Hamilton County Board of Supervisors in hereby authorized to File Hamilton County's opposition to NYSDEC's Adverse Abandonment Action (Docket # 1261), and be it further

RESOLVED, that Hamilton County hereby records its support for Warren County and the Town of Newcomb, and be it also

The Chairman stated that carrying through from Committee Day there was discussion of doing another resolution for Nursing and Community Services related to email encryption software. There are two issues with respect to that; one being procurement, two being the software provider and their legal counsel along with our County Attorney do not see eye to eye exactly on what liability should be in the instance that the encryption doesn't work. We are currently in the process of seeing whether or not there are other encryption services out there that might take a different approach with respect to the liability.

# 11:00 AM - Presentation of the Hamilton County Shared Services Plan

There is a copy of the County Wide Shared Services Initiative power point on the Board's desks for any future review with their Town Boards. The Chairman stated that there were 3 public hearings held to gather input and all 3 had a total of 3 people attending other than he. With having low attendance he stated that there weren't a lot of new ideas coming in from the outside. The Chairman took time to review the power point. The panel identified 6 projects that could be implemented by 2019 and additional projects that can be implemented beyond that. Short-term projects include: shared back office services, county-wide solid waste & recycling, LED street light conversion and joint purchasing. Some of the future projects include; police consolidation, consolidated snowmobile trail grooming and shared assessor. The power point handout also

showed some of the projected savings. Estimated net savings from short-term projects anticipated in the first year is \$86,500. Actual savings will be matched by NYS. Anticipated net recurring full year savings in future years is \$291,000.

Mr. Stortecky stated that the Town of Benson would like to be part of the LED street light conversion. He had spoken with Jessica, who had given the presentation on LED street lights, and indicated that they would need a pole and light at the Town Hall. He has not heard anything back yet. The Chairman stated that he would follow up and that there will be a coordination factor in terms of when we can line it up to then go to bid on the project. Mr. D. Wilt stated that he is waiting for pricing from National Grid. Mr. R. Wilt stated he too is having the same problem. Mr. D. Wilt stated that he had brought that up to Jessica and still hasn't heard back. The Chairman stated he would look into that as well.

# Other Reports:

Chairman: Stated that several of them had met with Senator Tedisco to go over Cathead Mountain, Town of Inlet Police Department consolidation and some other various issues. He thanked those that were able to be there on such short notice. The Senator was in Indian Lake during their Moose Festival and distributed grant funding while he met with a number of our community leaders. He was able to get \$500,000 for a number of municipal projects throughout the County and wanted to make sure we express our many thanks. The Chairman stated how he would like to see us get on a regular schedule for us to meet with the Senator. Maybe in the fall go down and talk about things that we are interested in for the upcoming legislative session along with having him come up here during a couple of the Board meetings to make presentations. There is also the idea of some of the Board members getting down to Albany during the legislative session.

The Chairman stated that we are in the process of looking into what we are required to do in the way of background checks for employees to satisfy the County's insurance renewal. We were notified by the insurance company regarding their concerns around us not doing background checks as extensively as they thought we should be. Waiting to hear back from Ms. Byrne as she was reaching out to other counties to see what they have in place. If we find there is no immediate impact on the County we would just have to figure out precisely what we want to do and have a policy in place before the renewal date of our insurance.

There will be a Public Works Committee meeting at 11:30AM upstairs in the Conference Room.
