Other Reports:

Mr. Wells: Stated that there will be an Internal Management Committee meeting this afternoon to discuss Merit and Step/Grade system. He does have a draft on the bereavement policy that he will make copies of and pass out.

The Chairman: Stated that Mr. Eldridge, Highway Superintendent, tried to get Barton & Loguidice to come in today to talk about where they were with the shared services work. They were not available to come in so we will reschedule them for a future date. There has been some discussion that we should be pursuing a recycling grant. Recycling grants are 50/50 match but there are some things that might enhance what towns and county is doing in a fairly cost effective way because there is some money to offset some of the capital cost. We have continued to struggle with the recyclables because of the cost to dispose of them and the management aspects.

The Chairman further stated that the County is still working on getting confirmation on approval of the Raise the Age plan. He was told that there are two counties within the state that have approval already and are fully vetted through. He thinks that we have moved to the next level of approval. He stated how he was cautiously optimistic that we are going to get the plan approved. As soon as we get the green light and we can be confident in the funding then we can move forward with Mr. Kleppang and the Sheriff and start to get the schools in place. We are clearly eligible to get the hard costs back and we have been fortunate enough not to have any detention costs yet. Counties are continuing to incur cost associated with detention and such without approved plans. We have taken a conservative approach in how we move forward with this not wanting to move forward with any services that we see as optional services until we get confirmation that the plan is approved.

The Chairman also stated that we have been heavily involved in this County around the work with aquatic invasive species. The Part 576 regulations at NYSDEC are up as does the Aquatic Invasive legislation sunset in the Spring of 2019. There has been some conversation that AATV has been asked to participate in strengthening that legislation. One of the things that was elevated from the Lake George area was the idea of doing mandatory boat washing and inspections which would provide another level of protection. The number of hours that we can have boat launches with steward's to do inspections would be a huge impact on the sporting community water access. He stated that we have to figure out how to increase the protections we are able to within the constraints of the system we have.

The Chairman: Stated that this Board was one of the early adopters of a resolution related to cell service and getting the cellular community to step up. The resolutions are passing fairly rapidly among other local governments. So he encourages the Board to take a look at either the resolution that AATV passed at the general membership meeting or the one that was passed here. Then to figure out whether or not it makes sense to take it back to their Town Boards and entertain it there.

As there was no further business, motion to adjourn by Mr. D Wilt, seconded by Mr. Seaman. Carried.
