FOURTH ANNUAL SESSION

NOVEMBER 26, 2018

The Board convened at 10:30 A.M. in the Supervisors' Chambers at the Court House, Lake Pleasant, New York, with the Chairman, William G. Farber presiding. Mr. Farber led the members of the Board of Supervisors in the Pledge of Allegiance to the Flag, and an opening prayer.

Public Comment:

Mr. Mark Hunt introduced himself as an employee of Hamilton County Highway. He has worked in that department for 36 years. He stated that he doesn't understand the step and grade system because after working here 30 years he doesn't have any more to gain. He stated that he would like to keep working in that department until he gets Social Security. In the last 10 years he has seen a lot of people come and go in his department. It seems to get harder and harder to find people to work anymore. He stated that if he retires the County has to pay his retirement and insurance on top of paying the new person's rate of pay and their insurance but if he stays the taxpayers save money. He stated that in the next 5 years there are going to be more employees asking the same question he is. He wants the Board to think about it and maybe come up with something. The Chairman thanked him for coming in.

Reports of Standing/Special Committees:

Mr. Wells: Stated that there was an Internal Management meeting that morning. The committee will be looking at drafts for the bereavement policy and for the employee evaluation policy.

Mr. Frey: Thanked everyone that had a hand in working over the weekend to make sure the budget was ready for today.

The Chairman stated that there is a bid opening for Spec. No. 9-2018 Regular Gasoline Unleaded (87 Octane). Ms. Lisa Johnson, Mr. Eldridge's Administrative Assistant is here to open them.

A motion was made to accept the bids and refer them to committee by Mr. Seaman, seconded by Mr. Wells. Carried.

Mr. Stortecky asked if we accepted GA Bove as our vendor what would happen with the other locations they didn't bid. The Chairman explained what has been done in the past and that if when reconciling OPIS to JOC Bove was the low bidder; the County would have to figure out if we could do partial award or not. His suspicion is that Petroleum Traders would not be interested in a partial award since a couple of the big delivery sites are taken off. There is no definitive answer. For the future we really should look at the bid specs as to what they say and how we award in those circumstances. Ms. Johnson stated that with the Diesel Bid Petroleum Traders did accept a partial award. Motion carried.

Budget Review:

The Chairman discussed all the changes made to the budget. We recently were told that there is a child that needs to be placed in an outside the county facility for 1 year. That added \$130,000 which comes out being 1.5% increase on the tax rate. It was a scramble going through the Fund Balance trends to see if the County could safely and securely absorb that within the existing budget and adopt that day. It is safe to say that we can.

The one thing that is not in the budget is the school and student resource program that Mr. Kleppang, Mental Health Director and the Sheriff have been working on. The County will have to do this as a budget amendment when they have more solid numbers. There is a possibility that some of the Raise the Age money could be used there. If that works the County should be able to put together a program. The Chairman stated he has a conference call scheduled with Mr. Kleppang and the Sheriff to go through an idea which is the Sheriff's Office contracting with Community Services to provide the Resource Officer and then Community Services would offer

the school and student resource program to the schools on a per day charge so the schools could opt in. This gives us greater flexibility to utilize the Raise the Age money and some Federal salary sharing money that Mr. Kleppang received, where we could make this cost neutral for the County and keep the cost down for the schools. We have always taken the approach that this had to be cost neutral to the County other than absorbing a couple of months of the deputy where they would be working in the summer months to help cover the influx of summer people while school is out.

There was some discussion around the amendment and adoption of the resolution on the Agenda. The Chairman gave more detail regarding the Coroner lines and what has changed in terms of those services.

Motion was made to open the Public Hearing on the 2019 Tentative Budget by Mr. Frey, seconded by Mr. Stortecky. Carried. No public present.

The Chairman stated that there is an adjustment for Assistant District Attorney. He further mentioned that the District Attorney would be in to speak with the Board. There have been discussions earlier in the year regarding time records and how to manage them. More recently there has been a conversation with respect to evaluations. The District Attorney wants the ADA to get merit but doesn't want to follow the evaluation procedure.

The Chairman discussed the Public Defender Accounts. There isn't office space for the Public Defender Coordinator so there is a need for rent. That cost can be covered by State funding. To come up with a budget number they used the lease amount for the office in Community Services.

The Chairman stated that once the budget is in place, the Board will need to pass a resolution to update the actual rate of pay for the Coroners at one of the December meetings. There remains a question posed by the Coroners of whether they should be paid a fixed salary or by per call basis. They now will be on payroll rather than paid by voucher.

The Budget Officer stated that there was the addition to the budget of extra hours in Personnel, 1430.104. This was to compensate Ms. Byrne for additional hours worked from time to time rather than changing her to 40 hours per week.

The Chairman asked the Budget Officer with all those changes, where it leaves the County in terms of percentage. The Budget Officer stated that the County is up \$156,878, which is an increase of 1.86%.

WHEREAS, the County has received a proposal from Fulton County that would enable Hamilton County to dispose of their MSW for a term of five (5) years beginning January 1, 2019 with an option to extend at the end of the initial five year agreement as follows –
