A motion was made to accept the bid and refer to committee by Mr. D. Wilt, seconded by Mr. Frey. Carried.

Reports of Standings/Special Committees: No reports.

The Chairman stated that the purpose of this Special Meeting is for approving a contract with the Village of Speculator for the collection of taxes. The Village of Speculator had a resignation of their longtime clerk and tax collector. The Village reached out to the County Treasurer's Office to see what they could do under the shared services model. The office already does tax collection for Lake Pleasant Central School; which is going well. After having a conversation with the Mayor and sharing the model we use with the school they were not only very interested but their board approved entering into an agreement. The timeframe is such that we need to setup the bank account and start collecting taxes before the next Board meeting so we need authorization before then.

Beth Hunt, County Treasurer, joined the meeting.

The Chairman stated that it would be the same model as the school. Ms. Hunt stated that it is 600 parcels which is less than half of what the school taxes are. It will be a good learning experience for the new Account Clerk in her office. They are all set. They will be able to pay online. They will be able to start June 1st.

AUTHORIZING THE HAMILTON COUNTY TREASURER TO BE THE COLLECTING OFFICER FOR THE VILLAGE OF SPECULATOR TAXES

WHEREAS, according to Real Property Tax Law Section 578-2, the County has the right to enter into a contract with a village for the collection of village taxes, and

WHEREAS, the Village of Speculator Trustees have agreed on May 13, 2019 to enter into a village tax collection agreement with Hamilton County for the collection year 2019, and

WHEREAS, the Hamilton County Treasurer has agreed to be the tax collecting officer for 2019 for the Village of Speculator during its normal village tax collection period of June 1 to November 1 with the collection office being the Hamilton County Treasurer's Office, be it

AUTHORIZING WEST PUBLISHING CORPORATION CONTRACT – COUNTY LAW LIBRARY

WHEREAS, Resolution No. 323-15 dated November 20, 2015 authorized a three (3) year contract with West Publishing Corporation to fulfill the County's need for a law library, and

WHEREAS, said contract has expired, and

WHEREAS, West Publishing Corporation has offered a new three (3) year contract for \$480.01 per month for the first year, increasing 2% per year for the remainder of the contract, therefore, be it

RESOLVED, that upon approval of the County Attorney, the Chairman of the Board of Supervisors is hereby authorized to sign a new three (3) year contract with West Publishing Corporation to fulfill the County's need for a law library.

After the following resolution was placed on the floor; the Chairman stated we have been very involved in the Hamlet to Huts program since its inception. We have also been heavily involved in meetings within the County because we are at the center of the Great South Woods. It has become evident that DEC is dealing more and more in partnership relationships rather than straight up having the capacity to come in and do trail development work. The way their resources have been drawn towards the high peak region communities we have been left behind. His suggestion

is to use the model that is used with the Moose River Plains where we step up and ask if they want partners to do this. The proposal would be that we will look at both approved trails and UMP's which is what the Great South Woods project looked at. We look at key connections which are necessary for the Hamlets to Huts program. We have some community connections where there is one little trail segment left to build otherwise the connection can't take place. In instances where we don't have those kinds of priorities, we would also look at some of our existing trails that are highly hiked but could be in better condition. We would develop the capacity so that through the contract with DEC we would get reimbursed for the work we would put in. We would step up and simply assure that our trail infrastructure gets the necessary attention it deserves going forward. We have worked with and talked to Steve Ovitt, Wilderness Property Management, in putting this together. Mr. Ovitt has a remarkable reputation. He has done some of the work in the Hamlets to Huts. We have worked with the Town of Long Lake to develop a trail segment that was necessary on the private land piece to make the connection. That went very well. He has done work in the Johnsburg area in terms of developing trails on private and state lands creating those connections. It has been pretty dramatic in terms of the impact it has had on the community. It would be a shortterm relationship having him help us build to capacity to do more of this on our own. Mr. R. Wilt stated that he didn't have a problem with this. The one thing is that we talk about maintenance of trails at the bottom of the list and he feels that they should be at the top of the list. The Chairman stated that could be sorted out. The idea is to make some sort of an advisory team to lead this. He will make sure the application doesn't set it up so one or the other has to be the priority. Included will be existing trails and trail connections identified in the Great South Woods trail developed in Hamlets to Huts. It's basically the implementation of those two grants as well as the trail work. Nancy Berkowitz has been great in working with us on the narrating of it. We will be getting a sample letter out, assuming it passes, for letters of support from the communities.

Mr. Wells stated the Forest Ranger in Moose River Plains called the Town of Indian Lake's Highway Department on Friday, which they don't work on Friday, to have them open the Plains up. He feels that the communication is terrible and that they could have been told Tuesday or Wednesday of that week. They went into Silver Run and put a chain up. It is not the Town's responsibility to open that road up apparently because they don't have the authority to close it. He is just throwing it out there that there needs to be better communication and that he would like to take a look at the contract. The Chairman stated that he thought he could fix that as he thought the communication was supposed to be between DEC and Tracy Eldridge, Highway Superintendent.

The Chairman stated that he would have the Clerk of the Board send an email with the agreement attached to Mr. Frey, Mr. Wells, Mr. Eldridge and himself to continue this conversation and find a fix for this situation.

Other Reports:

Mr. Seaman: Thanked everyone that showed up for the Memorial Day Parade. The Chairman stated, like always, Long Lake made an excellent host.

The Chairman stated that he and Mr. Frey had been having a conversation about something that was talked about at a Committee meeting awhile back. The County has an opportunity because of our inclusion in a shared service grant that Franklin County did, to take a step into evaluating the impacts and situation around short-term rentals in the County. He believes that people know the County has really tried to prioritize and figure out how to develop lodging within the County. We

have not had great success in that regard and he went on to explain the struggles the County has had with this. As James McKenna, ROOST CEO, has pointed out in some of his presentations we have really seen a dramatic uptick in Airbnbs and that market. From the standpoint of a tourism economy, it fills some of the demand. Take an area like Lake Placid they use second home rentals in profound ways to give themselves enough capacity to be able to handle their big events. We are seeing more and more second home rentals here as short-term rentals. His conversation with Mr. Frey was about setting up a committee to sit down and meet with Russ Kenyon, Grant Administrator for the 3-county area, to talk about the short-term rental issue. He stated that he was in Long Lake and had a chance to talk to both someone associated with the redevelopment of The Long View and what they are doing for a lodging business with cabins, rooms, etc. and someone who does Airbnb rentals. There was an amazing amount of connection there. He came away from those meetings feeling encouraged by the fact that we could do this with sort of comingling of Supervisors, some people that are involved in community development, lodging and Airbnb and we try to have a conversation about the strength, weaknesses and advantages it has. Let's see if there is a better way to optimize this change in market demand around short-term rentals. Mr. Frey, Mr. Kenyon and himself already have been having conversations and wanted to bring it back to the Board to make sure everyone thought it was a good idea. Mr. Frey stated that probably what will be discussed the most was what to do if, when and how bed tax will come into play. The Chairman stated that he didn't think so. He thought the difference in where we are in Hamilton County and where the other 2 counties are is that they have bed tax. So, for them the big issue was sort of the friction between existing lodging paying the bed tax, short-term rentals that weren't and how to overcome that; how to capture the people that are participating. He thought for us the conversation is a far more basic conversation about what is really changing within the market place. Through the grant they are really able to get us good data on what's really happening, what's really trending within short-term rentals. He feels that we can start on a far more basic level and he thinks the key is getting folks in that have worked on investing in lodging.

As there was no further business, motion to adjourn by Mr. Seaman, seconded by Mr. D. Wilt. Carried.
