Mr. Frey: Stated that the Adirondack Canoe Classic-90 Miler starts tomorrow.

Mr. Stortecky: Stated that the Hatch Brook Bridge Project is going extremely well. The temporary bridge is in. Thank you to all involved. Recently there were heavy rains that washed out CR6. Thank you to Tracy Eldridge, County Highway Superintendent for the quick response.

Mr. D. Wilt: Stated that he brought up the concerns regarding the signage for the wash stations but hasn't heard back yet. He just heard yesterday that DEC is closing the wash stations as of September 8th. The contract was supposed to be through Columbus Day Weekend. He is not sure what happened, he is waiting to hear back. The Chairman asked who was responsible for that decision. Mr. D. Wilt stated that DEC was. The Chairman asked if he would forward him that email and stated that he would follow up with them as well.

The Chairman: Discussed the 2020 Budget, including health insurance, state retirement and sales tax. For the upcoming Budget Meetings, Committee Chairs should be talking with their Department Heads about any significant requests. He discussed projects including maintenance

and upkeep of the Courthouse and grounds. Mr. Eldridge is working on getting prices to possibly start work this year regarding the columns. He feels there is an excess of \$50,000 worth of work between the front and the back of the Courthouse complex. It will need to be bid. Mr. Eldridge thinks that the steps can be replaced with granite on top. The Chairman discussed using some fund balance to fund up the Building Reserve to put us in a better position to take on these projects, particularly parking lots, building repairs, etc. The Independent Auditor has said that the County is getting to the point where we need to think about the level of fund balance. He stated that it is better to transfer fund balance into a Building Reserve rather than dramatically increasing the amount appropriated. He asked the Board to be thinking about that for their later budget talks along with any building issues to discuss with Mr. Eldridge.
