She stated how the Planning Board covers Hamilton County, and how they do Economic Development and Water Quality work for communities. They are currently hiring an Economic Development Coordinator and that candidate will be out to meet with everyone. She explained how they do grant writing at no charge to the municipality. They are there to help when or if anyone needs it. The Board thanked her for coming in.

Mr. Eldridge stated that there are resolutions on the Agenda authorizing the Fleet Coordinator to order vehicles. He will review these bids to make sure everything is good. If so, hopefully he will be able to get the Board a resolution to award, adding it to the Agenda today. The Chairman agreed by saying he saw no reason why they couldn't. Mr. Wells asked if these were a package bid or if he could pick and choose off both. Mr. Eldridge stated that he could choose off both and the low bid for each item will be awarded. He also stated, for the new Supervisors, that towns were able to piggyback off this bid.

#### State of the County:

The Chairman thanked everyone and stated how the County has a magnificent team that starts with the Supervisors and extends through all the employees. He discussed the political races of 2019 and how Judge Feldstein was a stabilizing factor for so long and on so many levels in terms of the work he did for Hamilton County. He discussed how the Halloween Storm damaged our infrastructure. He thanked everyone for their hard work and those that went above and beyond. He stated how it was amazing to see the communities come together to help out in the time of need. He feels that the community togetherness is a reason why so many people live here. He stated how we were at the start of the FEMA process with getting reimbursed at the County and Town level. How they were looking into why FEMA made the decision they had in regards to the individual home owner. He is hopeful for success in making an appeal. He welcomed that 2020 is a new day and discussed some of the upcoming projects including the Courthouse steps. His hope is to see more time allocated on maintenance and repairs to our office buildings and grounds. He discussed scheduling a road tour and went on to talk about the importance behind it. He talked about Solid Waste and stated that there was more to be done in regards to recycling. He discussed shared services from the financial side and how the Treasurer's Office is involved in that. He stated how the County has switched back to NYMIR for County Insurance which means that we are a part of that municipal reciprocal insurance. He talked about Public Health and how they we were able to rally and put a system in place after the Department of Health (DOH) promised that other providers would step up to help fill the gap and didn't. He stated the importance of having the CPA, Ms. Mahoney and the staff all discuss the Department's economics. He pointed out how fortunate the County was for having stable Health and Human Services Organizations. He talked about the work that both Robert Kleppang, Mental Health Director, and Karl Abrams, Sheriff, did on putting together a program for the schools so they could bring in a Resource Officer and/or Social Worker. He acknowledged Sterling Goodspeed, County Public Defender, and stated how he deserved a huge amount of credit for some of things he has been able to implement within his He thanked Sterling Goodspeed for a job well done. He stated how Gordon Purdy, Emergency Management Director, will be working hard on implementing another huge Emergency Communication Grant. A \$9,000,000 Grant that will be implemented partnering with Inlet. The goal is to build a system that is ours. A system that meets the needs of everyone. He acknowledged Christy Wilt, Economic Development and Tourism Director, and how she has

stepped up on the Economic Development and Tourism. She is a great example of a Department Head that has really come into a capacity and grown with us. He felt that on the Internal Management side there were times in 2019 when communication was better and that is something the Board needs to continue to work on. He stated that it might be that the Supervisors expect too much of the Personnel Department but he feels that they should be helping Personnel understand so to explain the County policies. He asked the Board to think about a better course of action to take when they have a message to get out. He welcomed the new Supervisors and stated how much energy he had received in talking to them. He would like to see the new Board find the right balance working together as a team using new ideas and passion in a way to produce a better outcome for the County in 2020.

## COUNTY OF HAMILTON PROPOSED LOCAL LAW NO. 6 OF THE YEAR 2020 A LOCAL LAW FIXING THE ANNUAL SALARIES OF THE HAMILTON COUNTY COMMISSIONERS OF THE BOARD OF ELECTIONS

Legislative Intent: The Hamilton County Commissioners of the Board of Elections annual salaries for the year 2019 were set by the Hamilton County Board of Supervisors at Forty-seven Thousand Four Hundred Twenty-four Dollars (\$47,424.00). That to bring the Hamilton County Commissioners of the Board of Elections annual salaries into conformity with the other appointed and elected officials, the annual salary for the Hamilton County Commissioners of the Board of Elections for the year 2020 will be Forty-nine Thousand Five Hundred Nine Dollars (\$49,509.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

- 1. That the Hamilton County Board of Supervisors hereby fixes the annual salary of the Hamilton County Commissioners of the Board of Elections for the year 2020 at Forty-nine Thousand Five Hundred Nine Dollars (\$49,509.00).
- 2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.
- 3. This local law is subject to a referendum on petition and shall take effect forty-five (45) days after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.

Other Reports:

Mr. Wells: Welcomed the new Supervisors. Told them to feel free to reach out at any time if they have any questions.

Mr. Frey: Welcomed the new Supervisors.

Mr. Stortecky: Welcomed the new Supervisors.

Mr. Eldridge addressed the Board stating that there was an issue with the bids they just awarded. He stated that the low bid for pickup trucks was awarded to Main Motorcar. In the bid specification he stated Chevrolets and when he called to verify, he found out they were Dodge pickups instead. He stated that Items 1 and 5 are legit. The Chairman asked if the Board had approved standardizing to Chevrolet. Mr. Eldridge stated that they had not. The Chairman asked whether there were any instances where Dodge's bid didn't meet what we wanted. Mr. Eldridge stated that they had written in minor differences from the actual specifications but none of which would have been thrown out. Mr. Stortecky asked if he wrote Chevrolet in the bid. Mr. Eldridge stated he had. Mr. Stortecky stated that Main Motorcar didn't comply. Mr. Wilt stated that standardizing the fleet would be the best way to get what we want. The Chairman stated that over the years the County has always done all brands; Ford, Dodge and Chevy. He also stated that the cleaner way to go about this, is do it as a two-step process. The County Attorney stated that if the County is going to bid for a specific vehicle then it should be standardized. He stated that under the circumstance he feels Mr. Eldridge should re-bid. Mr. Eldridge asked if it was okay to award Item 1 and Item 5.

A motion was made to re-open Resolution No. 2 by Mr. Stortecky, seconded by Mr. Wells. Carried.

The Chairman stated that the resolution was now reopened and the Board discussed the wording. The County Attorney asked if Mr. Eldridge thought it was in the best interest of the County not to accept the low bidder. Mr. Eldridge stated that he didn't have a problem with the Dodges his concern was the other bidder. The County Attorney agreed. The Chairman asked why they couldn't easily fix the resolution by moving an amendment to the resolved that says; *The Board of Supervisors does hereby award the bid for Items 1 and 5 to the lowest bidder of Items 1 and 5 as herein mentioned.* He would then bid the other Items. The County Attorney asked if they would have to reject bids. The Chairman stated that could be easily added to a second resolve.

The Board added an amended Resolution No. 2-20, on the floor, by Mr. Frey and seconded by Mr. Stortecky. Carried.

The Chairman asked to move having Resolution No. 42-20 Authorizing Fleet Coordinator to Purchase Pickup Trucks for 2020 reconsidered, on the floor, by Mr. Frey and seconded by Mr. Stortecky. All opposed. Resolution fails.

As there was no further business, motion to adjourn by Mr. Frey, seconded by Mr. Stortecky. Carried.
