Reports of Standings/Special Committees:

Mr. Frey: The Chairman stated that there are three departments that get a significant amount of state funding. These are Community Services, Public Health and Department of Social Services. He had observed individually how they are handling the anticipated state cuts. He and Mr. Frey both thought it prudent to meet with them prior to meeting with the Finance Committee. They have asked the departments to use the cut state aid at this point for their budget requests. Adjustments can be made later if needed. They still have to meet with Robert Kleppang, Community Services Director. After that meeting he and Mr. Frey will send out a memo to the departments on how to handle the state aid.

Mr. Arsenault: Stated that he, his events coordinator and Mr. Farber met with an engineer regarding mountain biking. Long Lake has been putting money into their budget for this. They are looking at developing Mount Sabattis. He discussed how impressed he was with the engineer and touched on his background. The Chairman stated that Lake Champlain Lake George Regional Planning

Board (LCLGRPB) had come to them with an opportunity to put in an application for Northern Border Funding. The application is for outdoor recreational resources. LCLGRPB has put in a letter of intent. They are trying to collect enough information to create a compelling application on behalf of the County. Then the County will be partnering with any of the towns that have money and want to; also working in parallel with the Trails into Prosperity project. He, Mr. Frey and Mr. Arsenault continued to discuss trails.

Mr. Stortecky: Asked if meeting with the Department Heads in a group to give an overview was still being considered. The Chairman stated that it was and he apologized for the delay of that.

Erica Mahoney, Public Health Director, entered the meeting and Mr. Eldridge left the meeting.

A motion was made to accept the bid and refer to committee by Mr. Tomlinson, seconded by Mr. Mauro. Carried.

The Chairman asked for Ms. Mahoney to talk to the Board in more detail about what it all means in terms of cost to the County. Ms. Mahoney stated that the transportation will be for 2 students. They will be going 4-days per week this school year and transport will be from Long Lake to Tupper Lake. Their day starts at 9AM and ends at 2PM. It isn't a far distance but is expensive. Last year it cost the County \$24,862. The amount is 59.5% reimbursable and the County has seen around \$15,000 back so far. It was a shorter school year last year due to COVID. The Chairman asked how many days per week it was last year. Ms. Mahoney stated that it was 5. The Chairman asked if she had heard anything regarding cuts to the preschool special education programs. Ms. Mahoney stated that she hasn't heard anything regarding that program. Mr. Tomlinson asked if the County were to do the transportation themselves would that also be reimbursable. The Chairman stated yes, it is still transportation and it doesn't matter how it happens. Ms. Mahoney stated that they are still waiting on one more payment and will let the Board know the adjusted numbers at that time. The Board went on to discuss taking on transportation.
