Tentative Budget Review:

The Budget Officer stated that he hasn't had a chance to discuss the couple lines with Tracy Eldridge, Highway Superintendent, so he didn't have anything to report on that. He and Mr. Frey both asked the Board if they had any budget questions they would like to discuss.

The Budget Officer stated that the changes they already had and the ones coming will be put together for Friday. There haven't been a lot of modifications to the Tentative Budget.

Other Reports:

Mr. Wells: Stated that he had to step away from the meeting.

Mr. Frey: Stated that all the places that either he or his wife have gone for doctors there are safety measures everywhere; with that, there are people that don't want to comply. The message is about staying safe.

The Chairman stated that because Mr. Wilt wasn't in attendance he still wanted to report on his behalf. The conversation was had between the Sheriff, Don Purdy, Emergency Services Director, and Barry Baker, Real Property Director, in respect to the GIS maintenance. Mr. Baker had since come back with an amended proposal from ESRI. The amendment showed a reduced number of servers which brings the total amount low enough where it could be signed off by the Chairman of the Board. Mr. Frey and Mr. Wilt will be part of that decision if all the department heads involved get back and say they approve.

Mr. Tomlinson: Stated his thanks to Mr. Frey, the Chairman and the Clerk of the Board for their work on the budget.

Mr. Arsenault: Stated his thanks for everyone's hard work on the budget. He feels that tough decisions were made but thinks they came out with a decent budget.

Ms. Bain: Stated that they had made tough decisions but they were the right decisions for 2021.

The Chairman stated that he had received some good news from the NYS Dept of Labor. August's unemployment numbers for Hamilton County were the lowest rate in the state.

Mr. Wells: Thanked everyone for their hard work. He stated that the Indian Lake Town Hall will now be working 4 days per week. Building Codes and Town Clerk will be appointment only. He hasn't spoken with the library but believes it will be shutting down again.
