A motion was made to accept the minutes of November 20, 2020 by Mr. Arsenault, seconded by Mr. Stortecky. Carried.

Public Comment: No Public.

Reports of Standings/Special Committees:

Mr. Wells: Stated all the meetings he had attended. AATV's meeting was on December 7th. There was an election of new officers and some shifting around of positions. 5-Towns meeting on December 9th. There is a lot of talk going on at the APA. Adirondack Park Local Government Review Board (LGRB) meeting on December 16th. It was Ron Moore's, Chairman (LGRB), last meeting. He stated to the Board that if any of them wanted any more detail from the meetings please email him. He is having trouble with the internet connection in Indian Lake and apologized for being short on everything.

The Chairman stated that hopefully by the Organizational meeting in January things will be better and they will be able to get back to in-person meetings. He discussed the COVID numbers and how from Thanksgiving to now things have changed within communities and it will take much better behavior to get back to that.

Mr. Mauro: Stated that there are more people quarantined in his area.

Mr. Frey: Shared his thanks to the County and the Nursing staff for the testing clinic held in Inlet. He feels that it has helped with the message for those struggling the most with deniers. The crosscounty testing has paid huge dividends. The Chairman further discussed and thanked him for all his help promoting it.

Mr. Wilt: Stated that there were a couple meetings regarding the microwave paths. There seems to be some possible obstructions in the way. The only way to find this out is to do the survey. The purchase orders have already been approved. They are going to move forward and hope that the paths work out. The Chairman thanked all involved on this. Without their due diligence there wouldn't be the level of confidence on these paths to move forward.

Mr. Tomlinson: Shared his thanks to Erica Mahoney, Public Health Director, and her staff for their hard work. There are a lot of Public Health resolutions on the agenda and asked for the Board's support. There is also a resolution to pay comp time and he asked if he should discuss. The Chairman further discussed and stated that even though this didn't go to Committee first he thought that the Board wouldn't want Ms. Mahoney to be taking time off at this point to use her accumulated comp time. She did have the money within her budget. He also stated he had authorized that Avis Warner, Public Health Registered Nurse, could accrue more than 40 hours comp time. Mr. Tomlinson stated that he appreciated the Chairman's help and appreciated all of what the nursing staff is doing for the County.

Mr. Arsenault: Stated that he felt the same as everyone else. Congratulated Public Health and the Chairman for their hard work. He feels that the County has been leaders so far but knows that we still have to remain diligent. The Chairman added that when the Board sees any of the School Superintendents that they should also be thanked for their hard work.
