FIFTH SESSION

MAY 5, 2022

The Board convened at 10:30 A.M. in the Supervisors' Chambers at the Court House, Lake Pleasant, New York, with the Chairman, Brian E. Wells presiding. Mr. Wells led the members of the Board of Supervisors in the Pledge of Allegiance to the Flag, and an opening prayer.

The Clerk, Mrs. Laura Abrams, called the roll with the following Supervisors answering:

Also present: County Attorney, Beth Hunt-Treasurer, Barry Baker-Real Property Tax Director/Budget Officer, Tracy Eldridge-Highway Superintendent and Kimberly Byrne-Personnel Officer

A motion was made to accept the minutes of April 7th and 25th, 2022 by Mr. Mauro, seconded by Ms. Bain, Carried.

Public Comment: No one present

The Chairman introduced Hamilton County District Attorney Christopher Shambo.

During the DA's department update he discussed legislative changes to discovery and Bail Reform and how they both have affected his office directly. He stated that the turnaround time currently for discovery is 35 days. He discussed that during COVID his office slowed down; that there wasn't as much law enforcement as well as arrests. He also stated how he reduced his budget at budget time because of the uncertainties of COVID and that his ADA, at that time, resigned. He discussed how Troop B and G for the NYS Police now have body cameras and how that adds to the discovery process. He further discussed how the caseload has changed with the lessening of restrictions around COVID. He stated how Indian Lake was his busiest court and how he had asked for additional staff during budget time. He discussed his staff and how he was absolutely blessed to have his current ADA, Susan Hartmann. He stated that there are 1 or 2 DWIs every week as well as a lot of larcenies. He recently asked for the Chairman's approval to increase the ADA's compensatory time up to 80 hours. One of the reasons was because of the time it takes to review body camera footage. He stated that even a simple DWI could be about 10 hours of footage

or more because sometimes there are two officers. He would like to hire an additional ADA. He asked that if the Board has any questions about his office to please call or visit him. He believes that the Sheriff's Office has a grant application in to get updated body cameras. That too would add an additional burden on his office. He stated that as a general rule if something was in possession of law enforcement it would be considered to be in possession of his office and that he is considered the head law enforcement individual for the County. He stated how the area was known for new NYS Troopers. If they aren't in compliance and cases get dismissed it reflects poorly on him. He stated that things have changed since the last DA was in office. He feels there isn't a complete understanding of what has changed and how the previous DA even needed to submit a letter for approval of additional compensatory time for her ADA. He stated how he really needs help. The Chairman asked if he was looking for another fulltime ADA or part-time. The DA stated that he would take what he could get. He discussed that being here, he wasn't sure who would apply. He thought that Saratoga County started the ADAs at \$92,000 and how in his meetings with DASNY he has learned that every office is looking for attorneys. The Chairman asked the DA if he had a monthly report of his cases. The Chairman stated that the Board needs to balance the amount of work he is claiming to have against a budget increase. There needs to be information. The DA stated that he appreciates the dialect and feels there hasn't been any. He stated that the office keeps old school records and that he could get the Board numbers.

The DA thanked the Board for allowing him time to come in. He stated how the NYS Troopers in Indian Lake stop in his office to visit and he welcomed the Board to do the same.

The District Attorney left the meeting at 11AM.

A motion was made at 11AM to open the Public Hearing on Proposed Local Law 9 of 2022 – Authorizing the Lease of Property in the Town of Long Lake Owned by Cedar Heights Timber, LLC. by Mr. Arsenault, seconded by Mr. Farber. Carried.

The County Attorney stated that the local law was to approve a lease longer than 5 years.

Mr. Farber asked if they had heard anything back about the parking area. Mr. Arsenault stated that he hadn't. He discussed there being a Hamilton County Fire Tower Challenge Map and would like to add Buck Mountain if agreement is signed. The County Attorney stated that there were a couple issues but he had spoken with the landowner's attorney and thought they had worked them out.

Reports of Standing/Special Committees:

Mr. Farber: Stated that during the biweekly call C&S Engineers and Jill Dunham, Emergency Services Director, updated them on where they were with all the tower projects. They were waiting on a part to get the Wells Tower online. They are making progress around the Hope location in terms of talking with Blue Sky. The balloon test for Morehouse location had been pushed back to the following day. The Arietta location is moving forward with the design. There are a couple of questions with respect to how they work out the final language for NYSEG Tower. He stated that he wasn't very optimistic about Cathead Mountain. The environmental group didn't like any of the language because it was less restrictive than they hoped for and the club wasn't satisfied either. Their attorney wrote a letter to the two Legislators.

Mr. Mauro: Stated he had spoken with Judge Morrison, President of the Magistrate's Association, and emailed Judge Coffinger, Hamilton County Court Judge in regards to the 2022 Court Consolidation Proposal. Judge Coffinger's return email stated that they didn't need to take any action. It would not affect the Town and Village Courts. Their meeting is scheduled for tomorrow and he thinks he will have an update from Judge Morrison.

Mr. Rhodes: Stated that Christy Wilt was working on a SCC Grant for Broadband in Lower Arietta. She is also advertising for the Tower Challenge.

The Chairman introduced Congresswoman Stefanik (via ZOOM).

Congresswoman Stefanik stated how they try to do updates with all the county elected officials across the district. She started by discussing redistricting. They won the court case where New Yorkers were challenging the redistricting lines and how the lines will now be drawn by a special map master. She stated that there was a new process for Congressional Directed Spending. This was the first time where they had appropriated direct line items and this past year, they successfully delivered all 10 prioritized projects. She would have Jonathan Carmen, District Manager, send the Board the information. They had just closed the application process for 2022 and many of the counties had submitted an application. She wanted to flag that as we are thinking about the priorities for the coming year and she would like to make sure Hamilton County is a part of that process. She stated the issues that she had been hearing - inflation, labor crisis, gas & energy prices and rural broadband.

She stated that this was a way she could hear from Hamilton County so she could be aware of what Hamilton County is focused on. The Chairman thanked her for all her email updates and thanked her for all that she does. Mr. Farber suggested that they schedule Mr. Carmen to meet with the Board. They have worked a lot on broadband and cellular and there isn't as much flexible money around cellular. It does look like FCC is going to be moving some of that. He stated that he had a good meeting with NACO and FCC discussing the idea of them moving money out to some of the areas while the map appeal is still going on. Congresswoman stated that it was a great idea and a real opportunity for Hamilton County.

Mr. Rhodes stated that they are applying for a FCC grant for lower Arietta which has no cellular service. They have several students from the Wells School District living there and are looking to get funding for broadband for those families as well as one business. He asked for Congresswoman Stefanik's support. The Congresswoman asked for him to flag that for Mr. Carmen. She also stated she was going to be at a meeting with one of the FCC Commissioners and wanted to make sure she flagged it for him as well. She stated that she would absolutely advocate for that. The Chairman thanked her for reaching out. The Congresswoman stated that they could always contact her, that she would follow up on those items for Hamilton County and thanked them for all that they do. The Congresswoman left the meeting at this time.

Reports of Standing/Special Committees: (continued)

Mr. Snyder: Stated that the information from Beth Hunt, Treasurer, regarding Opioid settlement

funds was on the Board's desks. The Board needs to decide how to spend it. Mr. Farber stated that there was a number of departments that this funding was available to and he feels there should be a conversation among all of them together.

Ms. Bain: Stated that there was a Health Committee meeting earlier this morning with Erica Mahoney, Public Health Director. After their discussion they decided that Ms. Mahoney needed to fill out a civil service job classification questionnaire as well as have one of the employees fill out a form to evaluate her position. The form was so the Board could see what she was doing now compared to what she was hired for as a medical records clerk. Once the paperwork is submitted the Committee would be meeting again.

County Attorney: Discussed the back taxes resolution that was on April's agenda. He asked Ms. Hunt if it was on the current foreclosure list or the judgement. Ms. Hunt stated it was on the judgement. The County Attorney asked if there was a different administrative fee if it has gone to judgement. Mr. Farber stated yes there was. The County Attorney stated that was what he thought. Ms. Hunt stated that she is expecting the payment that day and then she would be doing a letter to get the property off. Mr. Farber asked where the County was in the process. Ms. Hunt stated that this was with the Judge and not in the County's name yet. Mr. Farber discussed another situation where a property was further in the process and the liens were extinguished and then the family reached out to pay the back taxes.

WHEREAS, the Board of Supervisors initially authorized the original agreement with Fountains Spatial, Inc., for hosting and maintaining the server based County GIS Mapping application known as HAMCOMAPS.NET, and

WHEREAS, Fountains Spatial, Inc., has continued to host, maintain and modify the HOMS application through coordination with the Hamilton County Real Property Tax Services Agency since the inception in 2010, and

WHEREAS, on 2016 Fountains Spatial, Inc., merged operations with VHB, an engineering firm with offices in Albany, NY, and VHB will continue to provide the same service level agreements and application hosting to Hamilton County on a year to year basis going forward, and the Real Property Tax Services Agency recommends the Hamilton County Board of Supervisors renew the annual hosting agreement with VHB for 2022, therefore, be it

He thought that the State law was amended a few years prior when the issue came up specific to Hamilton County and the Legislature might have added to it. The County Attorney stated that he wished the question was presented to him prior but if in fact the matter is tabled, he could give a report prior to the next meeting. Mr. Farber stated that the recommendation was received on April 25th. Mr. Mauro stated that they could have a Special Session on May 23rd and still be within the 30 days. Mr. Mauro made a motion to table, seconded by Ms. Bain. Motion Carried. Mr. Arsenault asked why this was tabled. Mr. Mauro stated that it was to look through it more thoroughly. Mr. Arsenault asked if the Board would have to roll back the individual that is already in there. Mr. Farber stated that there is more to ask the County Attorney. In addition to what the County's role is there also seems to be conversation about whether or not they can make adjustments to salary during both the fiscal year and the term of an Election Commissioner. The County Attorney asked if the Board was suggesting that they wish

to pay the Commissioner's a different rate. Mr. Mauro stated that they need to look at how much time they are actually spending doing the work. The County Attorney asked how the Board would get that information between then and the next meeting. The Chairman stated that the resolution was tabled so there is room for some discussion and be able to act on it before anything has to happen. The County Attorney stated that he would look at it.

ADOPTION OF CHANGES TO HAMILTON COUNTY EMPLOYEE HANDBOOK

WHEREAS, the Board of Supervisors closed the County facilities on February 4th, 2022 and April 19th, 2022 due to extraordinary weather conditions, and

WHEREAS, after reviewing the Hamilton County Handbook regarding emergency situations and closing procedures, the Board of Supervisors determined there was a need to edit and replace the policy, and

WHEREAS, after reviewing the emergency situations policy the Board of Supervisors has recommended editing the prior to reporting to work section, and

WHEREAS, the Board of Supervisors has recommended replacing the prior to reporting to work section in the employee handbook, be it

RESOLVED, that Section 503 Emergency Situations – Prior to Reporting to Work section be edited from:

If a determination is made to close operations prior to the start of a workday, the Chairman of the Board of Supervisors will initiate notification to all affected employees. An employee who is directed not to report to work due to an emergency closing will not be paid for that workday. The employee may charge such absence to available vacation leave, compensatory time or personal leave credits or make up the time at a later date if agreed to by the Department Head, be it further

RESOLVED, that Section 503 Emergency Situations – Prior to Reporting to Work section be replaced with:

If a determination is made to close operations prior to the start of a workday, the Chairman of the Board of Supervisors will initiate notification to all affected employees. A full-time or part-time employee who is directed not to report to work due to an emergency closing will be paid for the employee's normal workday at the employee's regular rate of pay for that day. Such time will not be included as time worked for the purpose of computing overtime.

If a full-time or part-time employee is directed to report to work during the emergency closing, they will be provided with "Emergency Closing Credit Hours (ECCH)" for the hours they worked that day, but in no circumstance more than their standard work day (7 hours, 8 hours, etc.). If an employee worked more than their standard work day, they will be compensated for those hours through their department's payroll. When "ECCH" are earned and used, such time will not be included as time worked for the purpose of computing overtime. The "ECCH" must be used by the end of the year in which it is earned or within 30 days, if earned in December. An employee

who has previously scheduled a paid leave day must still charge the absence for the day to the appropriate paid leave, and be it further

RESOLVED, the policy is changed effective February 4, 2022, when the County first closed due to extraordinary weather conditions, and be it further

RESOLVED, that the Personnel Officer is hereby authorized to disseminate the changes to all employees and that a certified copy of this resolution be provided to the Hamilton County Personnel Officer.

BY MR. RHODES:

WHEREAS, a Project for the Bridge NY 2021: County Road 4 Over Big Brook (BIN 3307240), Bridge Replacement, Town of Indian Lake, Hamilton County, P.I.N. 2754.69.121 (the Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 95% Federal funds and 5% non-federal funds; and

WHEREAS, the Sponsor will design, let and construct the "project", and

WHEREAS, the County of Hamilton desires to advance the Project by making a commitment of 100% of the costs of the work for The Project or portions thereof, with the understanding that qualified costs may be eligible for federal-aid, state-aid, or reimbursement from Bridge NY funds, be it

RESOLVED, that the Hamilton County Board of Supervisors hereby authorizes the County of Hamilton to pay in the first instance 100% of the federal and non-federal share of the cost of The Project work for the Project or portions thereof, be it further

RESOLVED, that the Hamilton County Board of Supervisors hereby agrees that the County of Hamilton shall be responsible for all cost of the project which exceed the amount of the NY Bridge Funding awarded to the County of Hamilton, be it further

RESOLVED, that the sum of \$2,328,284.70.00 is hereby appropriated from Unappropriated County Road Fund Balance in accordance with Section 366 Subdivision 1 of the County Law and made available to cover the cost of participation in the above phase of the Project, be it further

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the Hamilton County Board of Supervisors shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof, be it further

RESOLVED, that the Chairman of the Hamilton County Board of Supervisors hereby agrees that construction of the Project shall begin no later than twenty-four (24) months after award and that the project shall be completed within thirty (30) months of commencing construction, be it further

WHEREAS, in the Town of Long Lake, on lands owned by Cedar Heights Timber, LLC exists the Buck Mt. Fire Tower, and

WHEREAS, Hamilton County has a very successful Fire Tower Challenge, and

WHEREAS, the Town of Long Lake wants to add this Fire Tower to the existing Fire Tower Challenge, and

WHEREAS, Cedar Heights Timber, LLC is willing to enter into a 10 year agreement to open the Fire Tower to the public, and

WHEREAS, Hamilton County possesses or has access to the resources and partners to implement this project, now, therefore,

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF HAMILTON, AS FOLLOWS:

Section 1. Cedar Heights Timber, LLC is the owner of property located in the Town of Long Lake by virtue of a deed from Lyme Adirondack Timberlands 1, LLC dated September 17, 2010 and recorded in the Hamilton County Clerk's Office on September 21, 2010 in Book of Deeds 251 at Page 504, being Tax Map Parcel No. 10.000-1-7.100.

Section 2. Cedar Heights Timber, LLC has agreed to lease to the County of Hamilton and to the Town of Long Lake a portion of the foregoing property including parking lot, trails and lands including a fire tower, being the historic Buck Mountain Fire Tower.

Section 3. The term of the proposed lease is ten (10) years.

Section 4. An analysis of the potential environmental impacts of the said lease, if any, has been done under the State Environmental Quality Review Act (SEQRA); the County of Hamilton authorized and directed the Town of Long Lake to act as lead agency. The Town of Long Lake determined the proposed action constitutes a Type II action, which determination the County of Hamilton ratifies and confirms.

Section 5. This Local Law is enacted to amend and supercede County Law Section 215(3) so as to authorize the County of Hamilton to enter into a lease of private property identified and as set forth hereinbefore, the purpose of superceding County Law Section 215 is to authorize the County to enter into a lease for a term exceeding five (5) years.

Section 6. The Chairman of the Board of Supervisors is authorized to enter into any and all agreements and execute all documents deemed necessary by the County Attorney for the lease of the above-described property from Cedar Heights Timber, LLC for a period of ten (10) years.

Section 7. This Local Law shall take effect upon filing in accordance with the provisions of the Municipal Home Rule Law of the State of New York

RESOLVED, that the Chairman of the Hamilton County Board of Supervisors is hereby authorized to enter into a 10 year access agreement with Cedar Heights Timber, LLC, with the approval of the County Attorney, and based on the following:

- Cedar Heights Timber, LLC/Finch Forest Management will have proposed South Sabattis Road Parking Area cleared and stumped (Tom Donnelly Logging of Long Lake to do the job).
- Hamilton County will assist with trucking of gravel from CHT-Campus Pit to cover Parking Area (Tom Donnelly to grade).
- Hamilton County will assist with trucking of Cobb rock from Mitchell's Tahawus Mine to Parking Area for top cover (Tom Donnelly to grade).
- Hamilton County will coordinate/contract with Adirondack Mountain Club and Hamilton County Soil & Water Conservation Crew to brush, sign and construct 1.2 mile of hiking trail from Parking Area to Buck Mt. Fire Tower.
- The Town of Long Lake will contract with Michael Vilegi to paint, replace steps, replace landings, replace Cab roof as well as install safety fencing on the stairs and landing areas on Buck Mt. Fire Tower.
- Town of Long Lake will provide the seasonal porta-john, monitor Parking Area for litter/trash and do light trail maintenance. Any major trail repair necessary will be the responsibility of Hamilton County.
- Town of Long Lake is to provide roadside signage at Parking Area for Buck Mt. Fire Tower Trail, No Camping signage and Trail Head Kiosk.
- Hamilton County will provide enforcement of the No Overnight Parking and No Camping provisions of the agreement.
- Cedar Heights Timber, LLC will agree to a 10 year, no fee, recreational access lease with Hamilton County for the Parking Area, Hiking Trail and Fire Tower. The Parking Area, Hiking Trail and Fire Tower will remain in the ownership of Cedar Heights Timber, LLC.
- Hamilton County and the Town of Long Lake will indemnify, defend, and hold harmless Cedar Heights Timber, LLC free and harmless from any loss, injury, damage, claim, lien, cost or expense,

including without limitation attorney's fees and costs that result in exercise of lease, breach of Agreement, or lack or compliance with laws of the State of New York.

• Hamilton County and the Town of Long Lake shall maintain General Liability Insurance which policy shall have minimum limits of \$1,000,000 combined single limit and \$2,000,000 general aggregate and shall name Cedar Heights Timber, LLC as Certificate Holder and Additional Insured. The County will also provide coverage under their Umbrella Liability at \$5,000,000 per occurrence and \$10,000,000 Aggregate, and be it also

Other Reports:

Mr. Farber: Stated that Adirondack Day was scheduled for that Monday in Albany but it has been canceled due to COVID. He thanked Mr. Rhodes and Christy Wilt, Economic Development/Tourism Director for all their help. The plan was to promote the fire towers and the challenge as part of that. He stated that he also left a copy of the AATV Legislative Agenda on each of the Board's desks. He feels that there were several things of great interest to the County in terms of the 2022 priorities. The cellular/broadband passage and Constitutional Amendments were numbers 1 and 2. He and the Chairman worked hard to make sure they scored well in terms of how they got prioritized by AATV. The Chairman stated that Mr. Farber has done a ton of work

in getting it out to the Board.

The Chairman: Stated that the Board received a request from Assemblyman Smullen for a letter of support for the Inlet/Webb joint Police Department Legislation A.2227. He asked the Board for their consensus. Mr. Farber stated that as long as Mr. Frey has continued to support this then the Board should support him and the Town of Inlet. He further discussed.

Mr. Eldridge: Stated that he hoped to be paving the Transfer Station next Friday and hopefully open it the following Friday. He stated that he received all the permits for Fayle Road Bridge and that he is still in the process of determining a day to start the Oxbow Lake Outlet Culvert. There was an issue with the wires being too low for equipment but he will keep Mr. Rhodes as well as the Arietta Highway Superintendent posted on this. He stated that they were paving Cramer Bridge today and hopes to have it open to the public in the following week. They will then be moving to Burnham Mill Bridge. He also discussed the spreadsheets for equipment rental and asphalt prices. He stated that with the prices being up he might have to do some rearranging to get some of the projects done. Mr. Farber asked if there has been a decrease in the number of equipment bidders. Mr. Eldridge stated that there has been. Mr. Farber stated that he thought the reduction for this year was striking. Mr. Eldridge stated that Finke is very competitive. Some of the other vendors that bid have not been competitive so they don't feel like it's worth their time. He stated that many of them are now available on NYS Contract but that there is also an equipment shortage.
