#### FIRST ANNUAL SESSION

#### **NOVEMBER 3, 2022**

The Board convened at 10:30 A.M. in the Supervisors' Chambers at the Court House, Lake Pleasant, New York, with the Chairman, Brian E. Wells presiding. Mr. Wells led the members of the Board of Supervisors in the Pledge of Allegiance to the Flag, and an opening prayer.

A motion was made to accept the minutes of October 6, 2022, by Mr. Mauro, seconded by Mr. Arsenault. Carried.

Public Comment: No one present.

County Attorney: No report.

Reports of Standing/Special Committees:

Mr. Farber: Stated that he attended the Adirondack InterCounty committee meeting. They did a tour of a Clinton County business at the airport. It is part of the redevelopment of the base. The business is developing electric airplanes. They can fly a couple hundred miles before they have to land and recharge. The majority of the meeting conversation surrounded the economy, state budget, state legislation, and NYSAC priorities for 2023. Sales tax has been on an upward trajectory for 2022. The state has some big looming gaps in their budget so they will all have to keep an eye on state revenues and some of the programs that are funded through state revenues.

Regarding emergency preparedness, they were asked by the Town of Arietta to follow up with some property owners that have some concerns about the one Arietta site. They have tried to

pursue and calm the concerns about it. The property owners have asked them to look at a variety of other sites. The full evaluation that they did keeps bringing them back to the area at the end of Route 10. What they did was develop data that showed they could be on either side of Route 10. The first site that they picked he feels is still the best site for a lot of reasons. He thanked Mr. Rhodes for having an emergency town board meeting in Arietta. He feels that the County and the Towns are partners in this emergency communication project. This is really about the County providing one emergency communication system to serve all of the towns as well as fire and ambulances. He had asked Mr. Rhodes and the Town Board if the Town was willing to have the County take extra time to evaluate an additional site in Arietta. He stated that himself, Mr. Rhodes and C&S went out and looked at the second site. He is hoping to move this as quickly as they can but there is a real possibility that they could lose a construction season with respect to Arietta by doing this. He stated that the Town Board wanted the County to review the other sites and that the County will make the investment. He felt this could be done in a way that respects the Town of Arietta, their residents and Town Board's desire but continues to keep the project moving forward.

Mr. Rhodes: Stated that Christy Wilt, Planning and Tourism Director, had been working on the IDA budget. It is now completed and submitted to the Public Authority's Recording Information System (PARIS). She will be attending an IDA meeting in the following week that will be covering the PARIS reporting, best practices, as well as tips for evaluating viable projects.

Mr. Tomlinson: Stated that there was an IDA meeting that morning and they are working on a workforce housing project with Oak Mountain. It is moving along well but there are a lot of steps involved.

As far as Public Works, there are two resolutions on the agenda, and he is looking for the Boards' support. There was also a Committee Meeting this week with Tracy Eldridge, Highway Superintendent. He also stated that his Town Highway Superintendent and himself did a road tour of their roads in Hope that were recently blacktopped, and Public Works did an incredible job. He thanked them for their hard work.

Mr. Arsenault: He stated that the last time he had spoken with Personnel they were still waiting to hear back from Burnham regarding whether or not Nathan Littauer and Excellus had worked their issue out. He asked if the Board had heard anything. The Chairman stated that there was a resolution on the agenda regarding health insurance.

#### PROCLAMATIONS:

The Chairman introduced Mr. Farber. Mr. Farber stated that it was his honor to get to present this proclamation. He was around when the Board of Supervisors participated with the Community Services Board and initially hired Robert Kleppang. It doesn't seem possible that it was 1999 when it occurred. It was an interesting hiring process as they are experiencing now with the fact that it's a blended group of the Community Services Board really having the ability to hire but the Board of Supervisors having the authority over the salary. He thinks that it really does require a partnership. He would love to say that they were wonderful in the way they implemented that because they got a great outcome. He thinks that the County was very lucky. They had some great candidates to choose from, but he thinks they made by far the best possible choice. Mr. Kleppang

has served Hamilton County so well. He then reflected on some of the things where Mr. Kleppang showed leadership and in bringing departments together. Mr. Farber explained how Judge Feldstein would talk about great things being done like the Coordinated Children Services Mr. Farber further discussed the visioning days Mr. Kleppang had set up at Minnowbrook trying to bring all the community stakeholders and leaders together to have conversations. But more recently, the work he did to bring the whole region together at Minnowbrook. He stated that it was a wonderful tenure that he had with the County. He moved the County so far forward internally and on a regional scale. He brought a level of understanding to some of Hamilton County's State Representatives about the problems and challenges here that really are unique. As well as that he was also always effective in talking about our strengths. It really was his honor to thank Mr. Kleppang for his service to the county. He read and presented the Proclamation to Mr. Kleppang. Mr. Kleppang expressed his thanks to the Board and to several people in Hamilton County. He stated that none of what he accomplished could have been done alone. He did it with the great support of the Board. He thanked the County Attorney and stated that it was great to work with him. He thanked the Board again. Stated that it had been an honor and wished everyone the best. He added that there was some good news to share. There are two finalists for the Director of Community Services position. They will be doing final interviews on Monday and the Community Services Board looks forward to making a recommendation. He feels that both are excellent candidates, and he thinks that the County will be in good hands. The Board applauded. The Chairman stated his appreciation and the one thing that stuck out to him was Mr. Kleppang's manner, dignity, grace and how he handled things. He looked up to that and thanked him.

PROPOSED LOCAL LAW NO. 13 OF 2022 State of New York

#### **County of Hamilton**

# A LOCAL LAW OVERRIDING THE TAX LEVY LIMIT FOR HAMILTON COUNTY FOR 2023 AND AUTHORIZING THE ADOPTION BY HAMILTON COUNTY OF A BUDGET FOR 2023 THAT WILL REQUIRE A TAX LEVY THAT IS GREATER THAN THE TAX LEVY LIMIT FOR THE 2023 FISCAL YEAR

BE IT ENACTED, by the Board of Supervisors of the County of Hamilton as follows:

- Section 1. Title: This Local Law shall be known as "Hamilton County Responsible Budgeting Law of 2022".
- Section 2. Declaration of intent: The intention of this local law is to comply with the requirements of General Municipal Law Section 3-c (5) prior to adopting the 2023 Hamilton County Budget. The dramatic economic changes precipitated by COVID, inflation, and workforce shortages have necessitated this increase. Notwithstanding these circumstances the County will need to provide services in 2023, in addition to those mandated by the State, which are important to our citizens. After serious and sustained efforts to minimize the amount of the tax levy, and to project the tax levy limit for Hamilton County for 2023, it is clear that a responsible budget for 2023 will require a tax levy that will be greater than the tax levy limit calculated pursuant to applicable State Law.
- Section 3. Budget Authorization: The Board of Supervisors hereby overrides the tax levy limit for Hamilton County for 2023 and authorizes Hamilton County, after completing all required procedures for the adoption of a budget, to adopt a budget for 2023 that will require a tax levy increase that is greater than the tax levy limit calculated for 2023 pursuant to Section 3-c of the General Municipal Law.
- Section 4. Severability: If any section, subsection, sentence, clause, phrase or other portion of this local law is for any reason declared unconstitutional, or invalid or in whole or in part by any court of competent jurisdiction, such portion shall be deemed severable and such unconstitutionality or invalidation shall not affect the validity of the remaining portions of this law which remaining portions shall remain in full force and effect.
- Section 5. Effective Date: This local law shall take effect upon the date on which a certified copy of this local law is filed in the office of the Secretary of State pursuant to section 27 of the Municipal Home Rule Law.

After the following resolution was placed on the floor; Mr. Rhodes stated that this locks the County in for a year. There is no way of knowing what the electric grids are going to do. Mr. Rhodes asked, the County must go out to bid for it, but National Grid doesn't bid? Mr. Eldridge explained that because of the amount of electricity the County buys they are bound by public bid statute to either bid it themselves or use someone like MEGA through NYSAC. This has been a conversation for quite a few years, and he felt that it has been difficult. He stated that sometimes National Grid isn't cheaper after locking in. The County does get a choice between 12-, 24-, 36- or 48-month contract. He gave the current rate of \$0.13534 and the County is currently paying \$0.09726 per kWh. He has been told that by December and January the number is going to go from \$0.13534 to \$.25 at least. Mr. Rhodes stated that companies have come and even to individuals claiming they can get it cheaper than National Grid but then ends up being more. Mr. Rhodes stated that he figured there was a reason for this and just wanted clarification. Mr. Farber further discussed. He also stated that he felt that they would do alright on this 12-month contract. Mr. Eldridge stated that he hated doing a yearly contract but feels it's a smart move.

Other Reports:

Mr. Farber: Stated that he attended the Lake Champlain Lake George Camoin meeting with respect to housing. He discussed the challenges and how it's getting worse. He stated that if the Board knew of any local discussions going on around this that they should get them to Beth Gilles, Director of Lake Champlain Lake George Regional Planning Board (LCLGRPB), Ms. Wilt or himself. He also stated that the Adirondack Association Town and Villages (AATV) general membership meeting is December 4<sup>th</sup> and 5<sup>th</sup> at the Courtyard Marriot in Lake George. One of the panels there will be related to some of the housing issues. Yes, some of it will be a reiteration of the Camoin data but there will also be a panel on the Broadband/Cellular issue.

Mr. Mauro: Asked what the County Attorney's opinion was on the District Attorney's Office not submitting his vouchers to pay his bills. The Chairman stated that he would like to discuss this later.

The Chairman made a motion to enter an Executive Session for the discussion of personnel, seconded by Mr. Mauro. Carried.

A motion to open the session by Mr. Mauro, seconded by Ms. Bain. Carried.

Steve Tomlinson left the meeting.

Tracy Eldridge, Beth Hunt and Barry Baker joined the meeting.

The Chairman stated that there was no action taken in Executive Session but at this time they will be setting up a committee meeting to meet with the District Attorney to discuss his budget concerns.

Barry Baker, Budget Officer, stated that the tentative budget is out and he thinks they have ended up better off at the end of the year. With that draft of the tentative budget, they were at about 8% above with raw numbers. If one of the objectives is to stay under the tax cap, he feels that is obtainable. Expenses are up everywhere. They have discussed differences for health insurance and he believes that what he has worked into health insurance would address that adequately. He thinks he is on the high end of that so the expense should come down a little bit wherever they settle out. He stated that on the revenue side he feels that the County will be up substantially above what the projections were for sales tax. He thinks they will probably top out at \$5Million or more. He feels they need to have a similar conversation for 2023. He feels his number is conservative. If they were to leave the number flat for 2023 then they would be under the tax cap. He also stated that if one of the objectives was to work on the compensation piece then that is also possible. They have ARPA funds and they could stay under the tax cap.

As there was no further business, the Chairman recessed the meeting until November 7, 2022 at 10:30 AM.
