Tracy reported that the highway projects are winding down. The 7<sup>th</sup> Lake bridge is wrapping up.

They are getting the plows ready for winter, the sand is all hauled.

Solid Waste is going well. Mr. Towers reported that the final revisions on the Solid Waste Management Plan draft are complete. Tracy will get the finalized information to Jillian.

For Buildings – Tracy reported they had a new boiler installed at the Lake Pleasant Highway Garage, but they still need to have the propane hooked up to it.

The above ground tanks have been installed in Indian Lake and they would like to hook up the generator in Indian Lake to the Public Health Department but there may be a size issue.

Bill reported that there is a resolution in for today. In June they authorized Tracy to order a medium duty truck but the plow specs were not heavy enough for that size truck. The correct plow for this truck will be an additional \$4,000 more.

Bill stated they could do a change order to purchase the truck without a plow or they can correct it so that they have the right plow. Tracy stated they will be plowing CR9 in Indian Lake and the parking areas.

At 11:00 AM the Board of Supervisors held their 2<sup>nd</sup> Special Session.

## FINANCE COMMITTEE 11:45 AM

Bill stated the Board of Supervisors have already discussed openly with Department Heads last year as well as this year in regards to a standard work day. What is the necessary numbers of hours a week for some department at certain times of the year?

If people see opportunities to cut, I think we need to pursue them. If at an efficiency standpoint you can get the work done with lesser hours that is superior to the alternative of cutting some of the programs or staff.

Ermina asked if a Town was to do that, shouldn't they coordinate with the County because of shared projects. Bill stated that if the Towns work closely it might make a difference but not with the County.

Ermina discussed her highway men working in Hope.

Bill asked, as we start through the budget and we now have a greater sense of where some of the departments are coming in, are there particular departments or out-side agencies that the County gives money to that the Board would want to come in during the annual sessions.

Everyone should have received an email encouraging counties to withhold Medicaid payments. This certainly shows the frustrations with the counties and taxpayers. Bill would like to know where the Board stands on this.

Bill asked if anyone on the Finance Committee would like a Finance Committee meeting during annual sessions, please let him know.
