FOURTH SESSION

APRIL 2, 2015

The Board convened at 10:30 A.M. in the Supervisors' Chambers at the Court House, Lake Pleasant, New York, with the Deputy Chairman, Brian Towers presiding. Mr. Towers led the members of the Board of Supervisors in the Pledge of Allegiance to the Flag, and an opening prayer.

A motion was made to accept the minutes of January 8, 2015, February 2, 2015, and March 5, 2015 by Mr. Wilt, seconded by Mr. McGovern. Carried.

Public Comment: Ms. Caitlyn Stewart from the Hamilton County Soil and Water Conservation District gave an overview of their spring programs.

Reports of Standings/Special Committees:

Mr. Wilt: We are finally getting somewhere on the radio system. The tower surveys were done last week with some glitches that need to be ironed out. He is hoping by next month, on Committee Day, they can extend the meeting to discuss PSAP and the tower system and decide how to move forward. For the PSAP part they are waiting for the bid process with Fulton County to see who the supplier will be. Also they will begin work on revamping the jail office within the next month or so, he expects the engineer next week to review the project.

Mr. Edwards: Mr. Towers and he attended the Intercounty meeting in St. Lawrence County. There was a presentation on their snowmobile trails. He asked that Deputy Chairman Towers discuss the NYSAC presentation.

Mr. McGovern: Mr. Osborne and Mr. Nervik are retiring. He wants to thank them both for their service.

Regarding Workforce Development, Mr. Bill Murphy has been chairing our Local Workforce Development Board for some time. Social Services has been doing a wonderful job and Ms. Dana Wilt has just shepherd through our first GED recipient under the program.

The Adirondack Local Government Review Board has meetings scheduled in various locations; they just held the most recent meeting in Speculator at Oak Mountain. He thanked them for the work that they have been doing on invasive species. There are others that have been working very hard on this as well and have gotten designated wash stations in the area.

Deputy Chairman Towers stated in regards to invasive species, the Committee will be meeting again tomorrow in Chestertown to continue to formulate where we are on the wash stations. It will be a challenge to get all nine wash stations up and running by Memorial Day.

Regarding NYSAC – Mr. Mark Lavigne was at Intercounty and did a presentation on where we were before the budget was adopted. Everyone should have received an email from Mr. Lavigne that has the breakdown of the budget.

A group met with Senator Richie last week regarding ATV's and motorized use on the forest preserve. She is trying to get an UTV bill through and was unsuccessful as part of this budget process.

DEC and Division of Budget is to coincide with the 480A program. They are promoting the idea to change the program, those who have less than a thousand acres will no longer be eligible to be in the 480A Program as it exists today. Deputy Chairman Towers continued to discuss.

Deputy Chairman then introduced Mr. Bill Murphy from Adirondack Teleworks.

Mr. Murphy handed out information and explained for those who aren't familiar with Teleworks the idea is simply using Broadband to create jobs. Mr. Murphy reviewed the handout information. He stated that he believes that the County receives around \$23,000 per year in WIA funding. As Treasurer of WIB he will be asking for an increase in this year's budget. The first year he worked with WIB they returned \$8,187.00 that didn't get used. The second year they returned \$5,817.00, and this year it will be under \$2,000.00. All due to the efforts of Dana Wilt, Roberta Bly and Neil McGovern, people who are really out there pushing for this type of program.

This is one of the reasons why he put together a plan for Adirondack Teleworks that would utilize those funds and not only are we using everything we are given but we can try to go for additional funding. He is asking the County for \$2,500.00 and he will match the \$2,500.00 for a total of \$5,000.00 to purchase a license for a cyber-school.

Mr. McGovern stated if we can gather some steam here, which Mr. Murphy has done for Adirondack Teleworks and tie to larger entities such as Paul Smith College we would have a home run here and is very much in support of investing in our future.

Deputy Chairman stated you have done a class in Indian Lake and had two graduate, but what constitutes success? I would think that we would need to put people in jobs also to be part of that success.

Mr. Murphy stated not one model fits everyone, we need to have a variety of partnerships so that we can connect people with the area that they are interested in. Deputy Chairman asked what his role is in connecting the people to those jobs. Mr. Murphy explain how people will get connected to jobs.

Mr. Murphy left after his presentation.
