The Chairman expressed to him that he was sure that the representatives from Hamilton County well represented our position; from his standpoint he feels there are a couple of factors, one that he doesn't feel there is an environmental need and that it is the wrong approach at the wrong time.

Mr. Frey: The Finance Committee met this morning and set the COLA at 1.75% for all employees. The County is behind on CPI and ECS with employees paying toward their health insurance so the County needs to keep pace.

Mr. Edwards: Had an Internal Management Committee meeting on Committee Day; Resolution No. 28 is the Merit resolution that came out of that meeting. He asked for support of the resolution.

Mr. Wells: Buildings/Public Works/Solid Waste met this morning. He complimented Highway Superintendent Eldridge for looking forward and has an understanding of what they are trying to do in the future.

Mr. McGovern: ROOST has assigned someone to cover exclusively Hamilton County and Tupper Lake. Things are moving forward and he is looking at how Dean will fit in with this contact person.

The Chairman announced that they will start on the resolutions; at 11:00 AM there will be a public hearing on Proposed Local Law No. 9 of 2014 so we will be stopping at that time and if there are any members of the public present they may speak.

# Other Reports:

Mr. Frey: On September 13<sup>th</sup> at 8:00 AM One Mile of Hope will take place in Inlet. They are trying to break the previous record.

Mr. Snyder: Attended Inter-county in Frankfort and toured the 3D Printing Company.

Mr. Wells: Thanked the County and everyone that participated in the Adirondack Challenge. He thanked the Chairman for all of the time he puts in. The Town of Indian Lake will be receiving \$750,000 for dam repair.

The Chairman thanked the Town of Indian Lake for hosting the event and what a great job they did.

Mr. McGovern: Stated Indian Lake did a great job. He thanked the Chairman for holding the medical provider meeting as well. The Town of Lake Pleasant, the Lake Pleasant Sacandaga Association, Hamilton County Soil and Water and Piseco Lake Association are working together on finding water fleas. They have found them in Sacandaga Lake in a number of places.

Mr. McGovern also reported that his town received a call last week from a resident who reported having hogweed and DEC was coming to remove it. Soil and Water went to the residence to confirm it was hogweed and it was confirmed as a wild salad which is not hogweed but closely resembles it. Caitlin from Soil and Water is going to be distributing information regard hogweed and how to identify it.

The Chairman stated with regards to Mr. McGovern's comment on the medical providers; the original thought of that meeting was that we had Community Services with Mental Health Services, Substance Abuse Services and our Certified Home Health Agency that really are an integrated part of the health care delivery system within the County, what the system is looking for is a higher level of integrated service provision between mental health and physical health. At the Community Service Board meeting they have been having conversations about the mental health services and how to integrate them. This started as a meeting where we talked about that opportunity and has now moved into something bigger and we will continue these talks.

The Chairman reported Mr. Seaman and he met with Public Health Director Susan Franko and from the meeting, they expect for Committee Day and for the September Board meeting that they will have some resolutions to reposition personnel within her office. This is long term planning for the department and for upcoming retirements.

The Chairman reported for Mr. Wilt that he met with Blue Wing and the 911 implementation. The tentative date for the next meeting is September 4<sup>th</sup> in the afternoon.

Mr. Purdy informed the Chairman that Mr. Mark Hoppe wants a RFP for legal services to help with permitting. This may be done through the APA, so we don't have a resolution on this for today.

They had their last PAC meeting for the Adirondack Strategies yesterday. The final report should be on-line in three weeks, next will be the implementation of the strategies.

The final meeting of the NCREDC was August 1st.

They are still working and moving ahead with SUNY ESF and DEC on the complex planning of the Great Southwoods.

At this time the Chairman asked for a motion to close the Public Hearing on Proposed Local Law No. 9 of 2014.

A motion was made to close the hearing by Mr. Towers, seconded by Mr. McGovern. Carried.

## **LOCAL LAW NO. 9 OF 2014**

# AMENDMENT TO LOCAL LAW NO. 4 OF THE YEAR 1988 ENTITLED "A LOCAL LAW TO REGULATE AND PROHIBIT THE MAKING OF UNNECESSARY LOUD AND DISTURBING NOISES WITHIN THE COUNTY OF HAMILTON

BE IT ENACTED, by the Board of Supervisors of the County of Hamilton, as follows:

**Section I** – Legislative Intent

The intent of this amendment is to reflect the change in value of a dollar, from 1988 to present.

**Section II** – Section 5 is hereby replaced as follows:

Section 5. Violations and Penalties: Any person who violates any of the provisions of this law shall be guilty of a violation and shall be punished as follows: upon conviction for the first offense, by a fine of not more than \$500.00, or by imprisonment for not more than five days, or both; upon conviction for each and every violation thereafter, by a fine of not more than \$2,000.00 and not less than \$500.00, or by imprisonment for not more than fifteen days, or both; each day that a violation is permitted to exist shall constitute a separate offense.

**Section III** – this Local Law shall take effect immediately upon its adoption and being filed in the Secretary of State's Office of the State of New York.
