## **EIGHTH SESSION**

#### **AUGUST 6, 2015**

The Board convened at 10:30 A.M. in the Supervisors' Chambers at the Court House, Lake Pleasant, New York, with the Chairman, William G. Farber presiding. Mr. Farber led the members of the Board of Supervisors in the Pledge of Allegiance to the Flag, and an opening prayer.

A motion was made to accept the minutes of July 2, 2015 by Mr. McGovern, seconded by Mr. Seaman, Carried.

Public Comment: No one present.

Reports of Standings/Special Committees:

Mr. Towers: July 14<sup>th</sup> was the Annual WIB meeting at the Inn in Speculator. Mr. McGovern discussed the new changes in WIB.

Mr. Towers reported he and Mr. Edwards attended Inter-county at Washington County. The NYSAC report mentioned that there has been between 500 and 600 bills passed by both houses of the Legislatures and we should look them over to see if anyone has concerns. The Tax Cap at this point is going to be .73. They talked about efficiency plans and if there are counties that are doing things a little differently from everyone else they should get that information to NYSAC.

Mr. Frey stated that a Tax Cap of .73 is very frustrating and a short discussion followed.

Mr. Wilt: Under the Interoperability Grant regarding the Blue Mountain tower, the road to the top is not usable. They have had several meetings with the stake holders and in the beginning it looked like it would cost the stake holders \$700,000.00 to \$800,000.00 to make the road usable. Homeland Security came through for the whole repair, this is huge for Hamilton County. The future plan for Blue Mountain is to have a microwave on top.

Monday morning at 10:00 AM there will be a meeting with Bob Vanderwalker and Mark Hoppe to discuss Dairy Hill tower.

For PSAP; tomorrow they are meeting with Frontier at 1:00 PM to discuss two quotes, one is the standalone system housed in Lake Pleasant the other is a remote through Fulton/Montgomery counties.

The drawings are back from the engineer for the layout of the PSAP center in the Jail and they hope to get the permit soon.

We have received access agreements from the landowners for the towers in Arietta and Morehouse. Chairman Farber reported people are working on cutting a path for the balloon test for Morehouse as we speak.

Mr. Wilt reported that he, Mr. Purdy and Superintendent Eldridge are going to walk the Arietta site today at 1:00 PM.

Mr. Edwards: Internal Management Committee met and completed employee evaluations and he is looking for support for the Merit Resolution.

Mr. Seaman: There are several resolutions under the Health and Human Services that he would appreciate support for.

Mr. McGovern: A permanent Tourism Aide was hired, Ms. RaChelle Hosley and she is doing very well.

Mr. Towers: Reported that Superintendent Eldridge has asked several times for a new generator for the Indian Lake Garage and he feels they should decide what they want to do.

Chairman Farber stated he will put it on the August Committee Day agenda so that they can discuss this.

The Chairman introduced County Historian Darling to discuss what next year brings for Hamilton County.

Historian Darling announced next year, 2016, will mark the 200<sup>th</sup> anniversary of Hamilton County. If everyone agrees that we should do something for the anniversary, the question is what we are going to do. How much are we going to do and most importantly who is going to do it. We have great volunteers but most are already very busy volunteering. Most places plan years ahead for something like this with a special committee, we have only five months.

Historian Darling mentioned a number of ideas that they could do. She feels that they should only do a weekend event due to so many activities already offered in the summer months, instead of a yearlong celebration.

Mr. Frey feels that a website would be a great idea.

Mr. McGovern threw out some ideas as well and the discussion continued.

Mr. McGovern stated that they have to look at the first season as a pilot with a learning curve of where the stations might be, the traffic patterns, what are the best days and hours, etc. But surely the signage has to be as welcoming as possible. Overall this has to be educational for the boaters. Going forward we need to make sure there is funding.

Mr. Towers stated his other concern is in year two are we going to have to figure out a mechanism for a matching grant or something for staffing. His understanding is after the first year, if we have stations, we will have to pay for the staffing. His other concern is putting municipalities in a situation where they are forced to come up with resources.

Chairman Farber stated we clearly have lake associations that want to see their lakes protected; some are saying maybe they should contribute. It is going to be difficult to navigate the differences on how to develop a park wide protection system.

Mr. McGovern: 5 Towns first multi-use trail has been announced and thanked everyone who has worked on this.
