MAY 5, 2016

Reports of Standings/Special Committees:

Mr. Towers: Inter-county was in Saratoga last week. The guest speaker was from the State Broadband Committee. They did a presentation to try to clear up some outstanding issues that communities have with regards to the rollout of the broadband project. It was insightful but feels there will still be a lot of questions that need to be answered.

WHEREAS, the IDA does not have the equipment or expertise to assist in this project, and

WHEREAS, the County has such capacity and Tracy Eldridge has reviewed the necessary hauling and confirmed that the County could do said hauling, and

WHEREAS, Tracy Eldridge has confirmed a budget for the hauling, of an amount not to exceed \$9,791.15, which would reimburse the County Highway Department for the full cost involved, now, therefore, be it
