## Public Comment: No one present.

Reports of Standings/Special Committees:
Mr. Towers: Attended the Review Board last week.
The Chairman stated there was one question the Review Board was pondering and has been pursuing with the APA; what constitutes a complete application and is there a process for appealing a staff determination that an application is incomplete. What is meant by an incomplete application? If you have an applicant that believes their application is complete and this is the project they want to submit, is the application really incomplete if the staff says no, they would like you to design it differently or is it really the staff recommending the denial of the permit and it ought to go before the park agency? Mr. Monroe and the APA staff have been going back and forth on this and he thinks it would be a good discussion for the Review Board to have. He feels this is the target of what the Review Board should be doing and also there is a concern they are hearing from applicants having to submit more and more paperwork.

Mr. Frey: Everyone has a copy of the tentative budget. He thanked Budget Officer Mezzano and everyone else who has been working on this, the department heads, Board of Supervisors Office etc.

Mr. Wilt: The Blue Mountain radio transfer project is moving ahead. There is a resolution on the agenda today to approve the purchase of new equipment. The time frame is tight due to winter coming. He also wanted it noted that there have been some accidents while working on the road to the tower.

The Chairman explained the people who have been working on the towers have been going up and down the mountain and there was a roll-over with an ATV. For those who have not been up there, there is a very treacherous traverse near the top, flat icy rocks and this is where the accident occurred. They will get as much done as they can this fall and then restart in the spring.

Mr. Wilt reported that the jail project is coming along very well. The PSAP equipment from Frontier has been delayed approximately a month. He asked the Chairman if he would like to touch on how the fiber is doing.

District Attorney Purdue entered at this time.
The Chairman stated there are a couple of things going on in regards to our fiber for the long-term for our dispatch center. The Developmental Authority of the North Country (DANC) built fiber from the foot of Blue Mountain to the top. They had a Homeland Security based grant that was part of Connect NY. They are able under the grant to connect our jail to the top of Blue Mountain but they don't have fiber that runs the whole way. Last week they worked out a deal between Frontier and DANC that is covered by the grant. DANC is able to swap and buy fiber from Frontier to create a connection from the top of Blue Mountain back to the jail.

The Chairman announced that County District Attorney Purdue is with them this morning. She asked for a brief executive session to give her the ability to discuss the specific performance of a county employee.

A motion was made by Mr. Towers to enter into executive session, seconded by Mr. Frey. Carried.
A motion was made to go back into open session by Mr. Frey, seconded by Mr. Wells. Carried.
The Chairman reported the Board met briefly with District Attorney Purdue to discuss the specific performance of an employee, no action was taken.

District Attorney Purdue announced Assistant District Attorney Goodspeed has resigned, his last day will be this Tuesday. She would like to advertise and try to find someone within the county. The Chairman told her that Officer Byrne can help her with the advertising. If they can't find someone within the county then she can seek out of the county.

PROPOSED LOCAL LAW NO. 12 OF 2015

State of New York

County of Hamilton

## A LOCAL LAW OVERRIDING THE TAX LEVY LIMIT FOR HAMILTON COUNTY FOR 2016 AND AUTHORIZING THE ADOPTION BY HAMILTON COUNTY OF A BUDGET FOR 2016 THAT WILL REQUIRE A TAX LEVY THAT IS GREATER THAN THE TAX LEVY LIMIT FOR THE 2016 FISCAL YEAR

BE IT ENACTED, by the Board of Supervisors of the County of Hamilton as follows:
Section 1. Title: This Local Law shall be known as "Hamilton County Responsible Budgeting Law of 2015".

Section 2. Declaration of intent: The intention of this local law is to comply with the requirements of General Municipal Law Section 3-c (5) prior to adopting the 2015 Hamilton County Budget. The slow recovery of the national, state and local economies from the most recent recession and the continued financial obligations imposed on the County by the State in the form of mandated government activities not fully funded by the State are conditions beyond the control of County government. Notwithstanding these circumstances the County will need to provide services in 2016, in addition to those mandated by the State, which are important to our citizens. After serious and sustained efforts to minimize the amount of the tax levy, and to project the tax levy limit for Hamilton County for 2016, it is clear that a responsible budget for 2016 will require a tax levy that will be greater than the tax levy limit calculated pursuant to applicable State Law.

Section 3. Budget Authorization: The Board of Supervisors hereby overrides the tax levy limit for Hamilton County for 2016 and authorizes Hamilton County, after completing all required procedures for the adoption of a budget, to adopt a budget for 2016 that will require a tax levy increase that is greater than the tax levy limit calculated for 2016 pursuant to Section 3-c of the General Municipal Law.

Section 4. Severability: If any section, subsection, sentence, clause, phrase or other portion of this local law is for any reason declared unconstitutional, or invalid or in whole or in part by any court of competent jurisdiction, such portion shall be deemed severable and such unconstitutionality or invalidation shall not affect the validity of the remaining portions of this law which remaining portions shall remain in full force and effect.

Section 5. Effective Date: This local law shall take effect upon the date on which a certified copy of this local law is filed in the office of the Secretary of State pursuant to section 27 of the Municipal Home Rule Law.

WHEREAS, Beth Ryan worked as Hamilton County Director of Patient Services and Public Health Director from Sept. 10, 1990 to July 1, 1999, and

WHEREAS, Beth Ryan then agreed to return to Hamilton County employment on Oct. 13, 2009 as a Supervising Community Health Nurse, and

WHEREAS, upon her return she inquired about the flexibility which could be applied to interpreting her eligibility for Retiree Health Insurance, and

WHEREAS, Beth Ryan then agreed to again serve as Director of Public Health/Director of Patient Services effective Jan. 1, 2011, and

WHEREAS, upon applying and interviewing for said position Beth Ryan informed the Board of her need for Retiree Insurance coverage and that in this significantly more stressful positon she would not be able to get in an additional 10 years of serving for the County, and

WHEREAS, the Board of Supervisors failed to resolve this issue at that time, and
WHEREAS, Beth Ryan has now indicated her intended retirement date at the end of 2015 which will give her 15 years of continual service though not all consecutive, and

WHEREAS, now the Board of Supervisors has to deal with Beth Ryan's prior request, now, therefore, be it

RESOLVED, that based on the fact that Beth Ryan has approximately 15 years of services to Hamilton County, the fact that she stepped in to fill the Director's role when the County desperately needed to fill a void, and the fact that the Board didn't previously authorized same, the Hamilton County Board of Supervisors hereby authorize Beth Ryan being covered as a retiree of Hamilton County, on the County insurance, under the same terms and conditions as all other retirees.

Certainly with the weight limit it has passed the Senate numerous times but has not been able to get through the Assembly at this point in time but we do have an Assemble majority sponsor as the resolution points out. He thinks this is an opportunity for us to address a number of ATV/UTV issues that have been out there for a long time.

## RESOLUTION IN SUPPORT OF AN ENVIRONMENTALLY SENSITIVE STATEWIDE ATV TRAIL SYSTEM

## DATED: NOVEMBER 5, 2015

## BY MR. TOWERS:

WHEREAS, the County of Hamilton recognizes the significant benefits associated with a multiuse trail system and thereby promote the safe and proper use of all-terrain vehicles for recreation and commerce within New York State by encouraging their use and development, while minimizing detrimental effects of such use upon the environment, and

WHEREAS, in order to best organize and sustain an environmentally sensitive statewide system of trails for all terrain vehicles, proposed legislation S05821 / A08399, sponsored by Senator Richie and Assemblyman Brindisi respectively, has been introduced to create a state-wide ATV trail plan and trail fund, and

WHEREAS, said proposed Trail Fund would be created for the purpose of designating state, municipal, and private lands as part of a statewide network of ATV trails with fees obtained by the Office of Parks, Recreation and Historic Preservation for the maintenance of the fund being divided between enforcement, education, and remediation (45\%), and the maintenance, construction, and development ( $45 \%$ ) of a statewide trail system in consultation with the Department of Environmental Conservation, and

WHEREAS, provisions for current trails and trails pending on or before the effective date of this Legislation would be preserved in perpetuity and nothing shall restrict the use of Commissioner Policy Three (CP3) Permits issued by the Department of Environmental Conservation on said trails, now, therefore, be it

RESOLVED, that the Hamilton County Board of Supervisors declares its support of proposed State Legislation S05821 / A08399, as sponsored by Senator Richie and Assemblyman Brindisi respectively, to create a state-wide ATV trail plan and trail fund that organizes and sustains an environmentally sensitive statewide system of trails for all terrain vehicles, and be it further

RESOLVED, that the Hamilton County Board supports amending S 2281 of the Vehicle and Traffic Law to define "all-terrain vehicle" or "ATV" as any self-propelled vehicle which is manufactured for sale for operation primarily on off-highway trails or off-highway competitions and only incidentally operated on public highways providing that such vehicle does not exceed seventy inches in width, or one thousand eight hundred pounds dry weight, and be it further

RESOLVED, that said support is contingent on final language that only prohibits ATV use on the "Albany Pine Bush", "Long Island Pine Barrens" and State owned lands that are classified as "Primitive" or "Canoe" pursuant to the Master Plan for the Management of State Land, and be it further
