Other Reports:

Mr. Towers: He and the Chairman attended the Forest Preserve Council Meeting last Friday. For the most part it was a good meeting, the session on the Great South Woods allowed us an update on what's been going on and the progress that's being made.

The Chairman reported as an update; the plan is to do another round of public outreach meetings in October to further engage the communities. The mapping project so far has captured a lot of ideas. This next round is going to have a display of proposed trails on the map.

Mr. McGovern stated it's such a large chunk of land they are talking about and the people who attended those first rounds were so diverse it was difficult jumping from map to map. If they already have a map made for those interest parties it would make things easier.

Mr. Towers stated the morning session focused primarily around Region Directors giving their update on what's been going on in their region and he thought there has been a great deal of mulling about cuts in staff, cuts in funding, cuts in capital projects, etc., and to take care of lands that they already have under their guidance. While sitting there he thought maybe they have finally come to the realization that we can't take care of what we already have, why we are going to continue down this road that we need more. At some point it's got to be black and white.

Mr. Wells: This is a reminder that the Citizen's Preparedness Corp Training Program at the Indian Lake Theater will be September 28th at 6 PM.

The Chairman stated they want to get citizens to be prepared for emergencies.

Mr. McGovern: Is involved with the Salt Reduction Study Group out of Paul Smith's. He would like to ask any of the Supervisors and/or their Highway Superintendents if they can come up with a list of spots that truly are problematic due to our overhead canopy. He is looking to put together a list from this county to start talks with Ennis. He is hoping for a 15% reduction of salt being put on our roads.

Mr. Towers asked where he came up with the 15%.

Mr. McGovern stated the four test areas have a decrease of 15% in salt.

A discussion took place on salting our roads.

The Chairman stated, for the NYSAC Conference, let's reach out to those who are going and coordinate who will be covering what.

As there was no further business, a motion was made to adjourn by Mr. Wells, seconded by Mr. McGovern. Carried.
