### Seeking Citizen and Stakeholder Input to Complete the Hamilton County Multi-Jurisdictional Local Hazard Mitigation Plan

**(March 11, 2020) Albany, NY-** The County of Hamilton, in partnership with New York State's Division of Homeland Security and Emergency Services (NYSDHSES), the University at Albany's Visualization and Informatics Laboratory (AVAIL), and Mountain View Planning, is currently updating the Hamilton County Multi-Jurisdictional Hazard Mitigation Plan.

This update is part of a state pilot program, funded by FEMA and administered by NYSDHSES. It is tasked with testing web-based software and integrated planning approaches designed for local hazard mitigation planning across New York State. AVAIL, a software laboratory in UAlbany's Geography and Planning Department, is working with Mountain View Planning to lead Hamilton County through the pilot hazard mitigation planning effort.

A hazard mitigation plan provides communities with an opportunity to work together to identify risk, evaluate vulnerabilities and develop strategies for risk reduction. Hamilton County currently has no Hazard Mitigation Plan, and one must be approved by FEMA in order for the County and participating jurisdictions to be eligible for FEMA mitigation grant funds.

Initial meetings with the Steering Committee and Core Planning Group kicked off in August 2020. Mountain View Planning and AVAIL are currently conducting jurisdictional interviews to collect community specific information. The information collected throughout the process is currently being reviewed and consolidated into the MitigateNY software.
